- (ii) **"authorised official"** means any official of the Council authorised to implement the provisions of these by-laws and also includes—
  - (a) a member of the Service as defined in section 1 of the South African Police Service Act, 1995 (Act No. 68 of 1995), or any amendment thereof; and
  - (b) a traffic officer appointed under section 3 of the Road Traffic Act, 1989 (Act No. 29 of 1989), or any amendment thereof;
- (iii) **"business"** means any act of selling, exchanging, renting or supplying goods and/or the rendering of any service for profit or reward on or in a public road or public place and includes the preparation, storage and/or display of goods or the advertising of goods and/or a service for such purpose, and "carry on business" has a corresponding meaning;
- (iv) **"Council"** means the Greater Louis Trichardt Municipality/Transitional Local Council and includes the Executive Committee of the Council or any official of the Council acting by virtue of any power vested in the Council in connection with these by-laws and delegated to it, him or her in terms of the provisions of section 58 of the Local Government (Administration and Elections), Ordinance, 1960 (Ordinance, No. 40 of 1960), or any amendment thereof;
- (v) **"garden or park"** means a garden or park as contemplated in section 63 of the Local Government Ordinance, 1939 (Ordinance No. 17 of 1939), or any amendment thereof;
- (vi) **"goods"** means any moveable article, receptacle, vehicle, displaying device or device or equipment for the rendering of a service used in connection with a business or for carrying on business and also includes any living animal used in connection therewith;
- (vii) **"lease"** means a lease agreement or any agreement in terms of which a stand is allocated to a specific vendor, at a rental (if applicable) as set out in Schedule 3 of these by-laws, and as contemplated in section 6A (3) of the Act;
- (viii) **"litter"** includes any goods, container or other matter which has been discarded, abandoned or left behind by a vendor or by his or her customers;
- (ix) **"national monument"** means any immovable property declared to be a national monument in terms of the provisions of the National Monuments Act, 1969 (Act No. 28 of 1969), or any amendment thereof;
- (x) **"prohibited area"** means any area declared from time to time in terms of the provisions of section 6A (2) of the Act by a resolution of the Council to be an area in which the carrying on of business is prohibited, and as set out in Schedule 1 to these by-laws;
- (xi) **"public place"** means a public place as defined in section 2 of the Local Government Ordinance, 1939 (Ordinance No. 17 of 1939), or any amendment thereof;
- (xii) **"public road"** means a public road as defined in section 1 of the Road Traffic Act, 1989 (Act No. 29 of 1989), or any amendment thereof;
- (xiii) **"restricted area"** means any area declared from time to time in terms of the provisions of section 6A (2) of the Act by resolution of the Council to be an area in which the carrying on of business is restricted, and as set out in Schedule 2 to these by-laws;
- (xiv) **"roadway"** means a roadway as defined in section 1 of the Road Traffic Act, 1989 (Act No. 29 of 1989), or any amendment thereof;
- (xv) **"service"** includes any advantage or gain offered in return for consideration or reward;
- (xvi) **"sidewalk"** means a sidewalk as defined in section 1 of the Road Traffic Act, 1989 (Act No. 29 of 1989), or any amendment thereof;
- (xvii) **"stand"** means a stand as contemplated in section 6A (3) of the Act;
- (xviii) **"vendor"** means a person carrying on business; and
- (xix) **"verge"** means a verge as defined in section 1 of the Road Traffic Act, 1989 (Act No. 29 of 1989), or any amendment thereof.

## REQUIREMENTS PERTAINING TO GENERAL CONDUCT

### 2. A vendor shall—

- (a) not place anything on any roadway;
- (b) ensure that his or her goods do not cover an area of public road or public place which is bigger in extent 2 m x 2 m and may in any event not leave less than 1,5 m of space, measured over the width thereof, on a sidewalk or any other part of public road or public space used for pedestrian traffic: Provided that where a sidewalk consists of a paved as well as an unpaved section, the area occupied by a vendor shall not leave less than 1,5 m of space on the paved section, measured over the width thereof;
- (c) not place or stack any goods in such a manner that it constitutes a danger to any person or is likely to cause injury to any person;
- (d) on concluding business for the day remove his or her goods, except for any temporary structure or minor building work approved and permitted by Council, to a place which is not part of a public road, public place or immovable property of the Council;
- (e) not display goods on a building or other private property without the consent of the owner, any occupier or person in control thereof;
- (f) on request by any official of the Council or any supplier of telecommunication, electricity, fire-brigade, ambulance or other services, move his or her goods so as to permit the carrying out of any work in relation to a public road, public place or any such service;
- (g) not attach any object by any means to any building, structure, pavement, tree, parking meter, traffic sign, fire hydrant, water-supply installation, electricity-supply installation, telecommunication installation, post box or similar structure or equipment on a public road or public place;
- (h) not make a fire at a place or in circumstances where it could injury to any person or damage to any property; and/or
- (i) not store any object in a manhole or stormwater drain.

## REQUIREMENTS PERTAINING TO CLEANLINESS

### 3. A vendor shall—

- (a) keep the area or stand occupied by him or her for such purpose in a clean and hygienic condition;
- (b) keep his or her goods in a clean and hygienic condition;
- (c) properly dispose of litter generated by his or her business and not dispose of litter in a manhole, stormwater drain or other place not intended for the disposal of litter;
- (d) ensure that on completion of business for the day, the area or stand occupied by him or her for such purpose is free of litter;
- (e) in the case of a vendor of foodstuffs, take such precautions as may be necessary to prevent the spilling onto any public road, public place or private property belonging to a person other than the vendor concerned, of any fat, oil, grease or other substance in the course of carrying on business and to prevent any smoke, fumes or odours emanating from his or her business from becoming a nuisance; and/or
- (f) on request of any official of the Council remove his or her goods so as to permit the cleansing of the surface of the area or stand where he or she is carrying on business.

## OBSTRUCTION PROHIBITED

### 4. No person shall carry on business where it—

- (a) obstructs access to any facility intended for the use of the general public;
- (b) obstructs access to any fire hydrant or manhole;
- (c) obstructs the visibility of a display window in business premises or any part thereof, if the person conducting business in the business premises concerned objects thereto and such objection has been made known to the first-mentioned;
- (d) obstructs access to or proper and undisturbed use of an entrance to or exit from, any private property belonging to a person other than the vendor concerned, or building which is the property of the State or the Council;
- (e) obstructs access to or the proper and undisturbed use of a pedestrian crossing;
- (f) obstructs access to any vehicle;
- (g) in any other manner substantially obstructs pedestrians in their use of the sidewalk;
- (h) causes an obstruction on the roadway;
- (i) limits or impedes access to parking or loading bays or other facilities for vehicular traffic, including such bays or facilities provided on any private property in terms of the provision of the Louis Trichardt Town-planning Scheme, 1981, or any other town-planning scheme in operation in terms of the provisions of the Township and Town-planning Ordinance, 1986 (Ordinance No. 15 of 1986), or any amendment thereof;

- (j) obscures any traffic sign or marking or any other marking, notice or sign displayed in terms of these or any other by-laws of the Council; and/or
- (h) interferes in any way with any vehicle which may be parked alongside such place.

#### CARRYING ON OF BUSINESS PROHIBITED IN CERTAIN PLACES

5. Save as provided in section 6, no person shall carry on business—

- (a) in any garden or park to which the public has a right of access;
- (b) on a verge contiguous to—
  - (aa) a building belonging to, or occupied solely by, the State or the Council;
  - (bb) a church or other place of workshop;
  - (cc) a national monument; or
  - (dd) a building in which business is conducted by any person, which business is of the same nature as or similar in nature to the business carried on by the first-mentioned, without the consent of that person;
- (c) on that half of a public road contiguous to a building used for residential purposes, if the owner, any occupier or the person in control of the building objects thereto and such objection has been made known to the first-mentioned; or
- (d) any prohibited area.

#### CARRYING ON OF BUSINESS RESTRICTED IN CERTAIN PLACES

6. Notwithstanding the provisions of section 5, the carrying on of business may be allowed in gardens or parks specified by a resolution of the Council or in any restricted area: Provided that no person shall carry on business in any such garden, park or restricted area—

- (a) unless he or she has entered into a lease agreement with Council, if so required by Council;
- (b) outside the stand set aside and demarcated by Council;
- (c) If he or she is not in possession of proof that he or she has leased such stand from the Council or that it has otherwise been allocated to him or her by the Council, for inspection by an authorised official when so requested by such official;
- (d) outside the hours determined by resolution of the Council and of which written notice has been given to the vendors concerned; and/or
- (e) with goods other than those specified by a resolution of the Council and of which written notice has been given to the vendors concerned.

#### REMOVAL, IMPOUNDMENT AND DISPOSAL OF GOODS

7. (1) Any authorised official has the power to remove and impound any goods—

- (a) which he or she reasonably suspects are being used or intended to be used or have been used in or connection with business; and
- (b) which he or she finds at a place where in terms of the provisions of section 4, 5 or 6 of these by-laws, the carrying on of business is prohibited or restricted, and which in his or her opinion constitute an infringement of such section,

whether or not such goods or any part thereof are in the possession or under the control of any person at the time of such removal and impoundment.

- (2) In the event of goods which are to be removed and impounded in terms of the provisions of subsection (1), being in the possession or under the control of any person, then the authorised official performing such removal and impoundment shall issue to such person a receipt stating the date and time, the place or address from which the goods are to be removed, the name and address of the owner of such goods, if known, as well as giving a description of the relevant goods and the quantity thereof.
- (3) Goods removed and impounded in terms of the provisions of subsection (1) shall be delivered forthwith for safekeeping by the relevant authorised official to the Council's Stores, or in the case of living animals to Council's Animal Pound, and upon receipt thereof the Storeman or other official in control of the Stores or Pound shall enter the information as contemplated in subsection (2) in a register specially kept by Council for such purpose as well as take into his or her possession for safekeeping together with such register any copies of receipts issued in terms of the provisions of subsection (2).

- (4) Perishable goods or any other goods intended but no longer fit for human consumption shall be destroyed within a period of twenty-four hours from the time of removal and impoundment, or such shorter period as specific circumstances pertaining to the condition of such goods may necessitate, by an authorised official in the presence of at least two other Council officials, whereafter the register as contemplated in subsection (3) shall be endorsed accordingly and signed by all three such officials, if not claimed within such period by the owner thereof on production of proof of ownership to the satisfaction of the Council as well as on payment of the pound fees determined from time to time by Council in terms of the provisions of section 80B of the Local Government Ordinance, 1939 (Ordinance No. 17 of 1939), or any amendment thereof and as furthermore set out in Schedule 3 to these by-laws.
- (5) (a) Council shall at such regular intervals as it may determine by resolution, cause to be published a notice in an Afrikaans and an English newspaper circulating in Council's area of jurisdiction, containing the following information pertaining to goods removed and impounded in terms of the provisions of subsection (1) but excluding goods as contemplated in subsection (4):
- (i) a description of the goods, the quantity thereof, the address where it is stored and if known, the name and address of the owner;
  - (ii) a statement that the goods may be claimed by the owners thereof on production of proof of ownership to the satisfaction of the Council as well as on payment of the pound fees contemplated in subsection (4);
  - (iii) a statement that any goods which remain unclaimed for a period of three months after the date of publication of such notice shall be destroyed if of no commercial value, or sold by public auction and the proceeds of such auction shall be retained by Council to defray its costs.
- (b) In the event of goods removed and impounded in terms of the provisions of subsection (1) being living animals, such animals shall notwithstanding the provisions of paragraph (a), be dealt with in accordance with the provisions of the Local Authorities Pound Regulations promulgated under Administrator's Notice No. 2 of 2 January 1929, or any amendment thereof.
- (6) Council shall destroy or sell by public auction unclaimed goods as contemplated in subsection (5) (a) (iii), in which event the provisions of subsection (4) shall apply *mutatis mutandis*.
- (7) Council shall not be liable for compensation to any person for damages arising out of the damage to or loss of goods removed and impounded in terms of the provisions of subsection (1) or the sale thereof by public auction, and the owner of such goods shall have no claim or right of redress against the Council should such goods be handed over in good faith to a person other than the owner thereof.
- (8) (a) If any goods contemplated in subsection (1) are attached to any immovable property or fixture and such goods are under the apparent control of a person thereat, an authorised official may direct such person to remove the goods from such property or fixture, and such person shall be compelled to comply with such directive.
- (b) If a person fails to comply with a directive as contemplated in paragraph (a), an authorised official may take such steps as may be necessary to remove the goods.

#### VICARIOUS LIABILITY

- (9) Any contravention of any of the provisions of these by-laws by an employee of an employer who carries on business, shall in addition to the liability of such employee in terms of the provisions of section 10, be deemed to have been committed by such employer, unless such employer satisfies the Court that—
- (a) he or she neither connived at nor permitted the act or omission by the employee concerned; and
  - (b) he or she took reasonable steps to prevent the act or omission; or
  - (c) the act or omission did under no circumstances fall within the scope of employment of the employee concerned.

#### OFFENCES AND PENALTIES

10. Any person who contravenes any provision of these by-laws or fails to comply therewith shall be guilty of an offence and liable on conviction to a fine not exceeding R1 000,00 or to imprisonment for a period not exceeding three months.

- (i) mag nie enige voorwerp in 'n mangat of stormwatersloot berg nie.

### VEREISTES MET BETREKKING TOT SINDELIKHEID

#### 3. 'n Straathandelaar moet—

- (a) die staanplek deur hom of haar vir sodanige doel beset in 'n skoon en higiëniese toestand hou;
- (b) sy of haar goedere in 'n skoon en higiëniese toestand hou;

- (h) op enige wyse met enige voertuig wat langs sodanige plek geparkeer is, inmeng nie.

### HANDEL DRYF VERBODE OP SEKERE PLEKKE

#### 5. Behoudens die bepalings van artikel 6 mag geen persoon handel dryf—

- (a) in enige tuin of park waartoe die publiek 'n reg van toegang het nie;
- (b) op 'n soom naasliggend aan—
  - (aa) 'n gebou wat behoort aan, of hoofsaaklik beset word deur die Staat of die Raad;

- (bb) 'n kerk of enige ander plek van aanbidding;
- (cc) 'n nasionale monument; of
- (dd) 'n gebou waarin besigheid bedryf word deur enige persoon wie se besigheid van dieselfde aard of soortgelyk is aan die besigheid wat deur die betrokke straathandelaar bedryf word, sonder die toestemming van daardie persoon nie;
- (c) op daardie helfte van 'n openbare pad naasliggend aan 'n gebou vir woondoeleindes gebruik nie, indien die eienaar, enige huurder of die persoon in beheer van die gebou, daarteen beswaar maak en sodanige beswaar aan eersgenoemde bekend gemaak is; en/of

#### HANDEL DRYF BEPERK OP SEKERE PLEKKE

  - (a) tensy hy of sy 'n huurooreenkoms met die Raad aangegaan het, indien so vereis deur die Raad;
  - (b) buite die staanplek afgesonder en gemerk deur die Raad;
  - (c) indien hy of sy nie in besit is van 'n bewys dat hy of sy sodanige staanplek van die Raad huur of dat dit andersins aan hom of haar deur die Raad toegeken is, vir inspeksie deur 'n gemagtigde amptenaar wanneer daartoe versoek;

- (2) In die geval waar goedere wat verwyder en geskut staan te word ingevolge die bepalings van subartikel (1), in die besit of onder die beheer is van enige persoon, moet die gemagtigde beampte wat sodanige verwydering en skutting hanteer, aan sodanige persoon 'n kwitansie uitreik waarop die datum en tyd, die plek of adres waarvandaan die goedere verwyder word, die naam en adres van die eienaar van sodanige goedere, indien bekend, asook 'n beskrywing van die betrokke goedere en hoeveelheid daarvan aangetoon word.

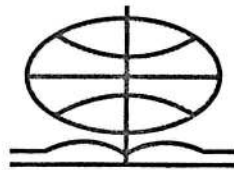
