9. Appointed members of a governing body

- (1) The elected members of a governing body, at the meeting referred to in regulation 21 of Notice No. 243 of 1997 shall cause members contemplated in regulation 2 in this Schedule to appoint representatives to the governing body.
 - (2) A member of a governing body appointed under regulation 9 (1) in this Schedule shall not have the right to vote or hold office.
 - (3) The principal of the school shall notify the Head of Department in writing of the names of appointed members.
 - (4) No act of the governing body shall be invalid merely because a member, is for any reason what so ever, not represented on the governing body in terms of regulation 9 in this Schedule.
10. The provisions of Chapter 3 of Notice No. 243 of 1997 shall apply to office-bearers, meetings and procedures of governing body in this Schedule.
11. **Interpretation**
- (1) Subject to regulation 29 (2) of Notice No. 243 of 1997 and unless the context indicates otherwise, a word which is defined in the Act shall have the same meaning in this Schedule.
12. **Date of Commencement**

The provisions in this Schedule shall come into effect on the date of this Notice.
