It is hereby notified that the Premier has assented to the following Act which is hereby published for general information—

No. 3 of 1998: Northern Province Appropriation Act, 1998

ACT

To appropriate monies in the Provincial Revenue Fund of the Northern Province for the requirements of the Province during the financial year ending 31 March 1999

(*English text signed by the Premier*)
(Assented to on 30 June 1998)

BE IT ENACTED by the Provincial Legislature of the Northern Province, as follows—

Appropriation of monies for the requirements of the Northern Province

1. Subject to the provisions of the Northern Transvaal Provincial Exchequer Act, 1994 (Act No. 3 of 1994), there is hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province, in respect of the financial Year ending 31 March 1999, as a charge against the Provincial Revenue Fund, amounts of money shown in the Schedule hereto.

Short title

2. This Act shall be called the Northern Province Appropriation Act, 1998.
