- (c) a peace officer as contemplated in section 334 of the Criminal Procedure Act, 1977 (Act No. 51 of 1977);
- (d) a representative of the "Association" authorized thereto by the Association and in terms of the Agreement.

1.5 **"business"** in relation to any garden, park or public road as defined in section 1 of the Road Traffic Act, 1989 (Act 29 of 1989), shall mean any act of the selling or supplying of goods and/or the rendering of any service which in the opinion of the authorised officer constitutes the actual selling, supplying or rendering or any attempt to exercise such an activity;

1.6 **"carry on a business"** shall mean to display goods for sale by inviting others to come and buy the goods so displayed;

1.7 **"Council"** shall mean the Greater Messina Transitional Local Council established under proclamation 10 of 1996 and of which Council was designated in terms of Act 21 of the Business Act, by Proclamation 29 of 14 April 1994 in the Extraordinary Gazette;

1.11 **"municipal area"** shall mean the area of jurisdiction of the Council;

1.12 **"a park"** shall mean a public open space as defined in section 63 of the Local Government Ordinance No. 17 of 1939, as amended;

1.13 **"permit"** shall mean proof of hawkers right to a stand as issued by the Council or Organisation authorized to issue such permit;

1.14 **"public road"** shall mean any road, street, through fare, bridge, overhead bridge, subway, foot pavement, footpath, sidewalk and lane as contemplated for in section 63 of the Local Government Ordinance 1939 (Ordinance No. 17 of 1939) and section 1 of the Road Traffic Act (Act No. 29 of 1989) as amended;

1.15 **"regulations"** Published in terms of these By-laws from time to time to govern the functioning and powers of the Hawkers Association as 1.3;

1.16 **"Sidewalk"** shall mean that portion of a verge intended for the exclusive use of pedestrians;

1.17 **"stand"** shall mean a stand as contemplated in section 6A (3) of the Act;

**2. PROHIBITION ON CARRYING ON OF BUSINESS**

2.2 on a verge contiguous to—

- (a) a building belonging to, or occupied solely by, the State, or the Council concerned;
- (b) a church or other place of worship; or
- (c) a building declared to be a national monument under the National Monuments Act, 1969 (Act No. 28 of 1969);

2.3 in an area declared by the Council as prohibited area in terms of section 6A(2) of the Act, excluding a stand lease by virtue of a lease agreement as contemplated in Section 4;

2.4 at a place where—

- (a) it causes an obstruction in front of a fire hydrant or an entrance to or exit from a building;
- (b) it causes an obstruction to vehicular traffic; or
- (c) it substantially obstructs pedestrians in their use of a sidewalk and

2.5 on a verge so defined continues to a building in which business is being carrying on by any person who sells goods of the same nature as/or of a similar nature to goods being sold by the street vendor, pedlar or hawker concerned;

2.6 on that half of a public road contiguous to a building used for residential purposes, if the owner or person in control or any occupier of the building objects to it.

### 3. THE RESTRICTION OF THE CARRYING ON OF BUSINESS

No person shall in the municipal area carry on a business of a street vendor—

3.1 in a garden or park or sidewalk;

3.2 on a verge contiguous to—

- (a) a building belonging to, or occupied solely by, the State, or the Council concerned;
- (b) a church or other place of worship; or
- (c) a building declared to be a National Monuments Act, 1969 (Act No. 28 of 1969);

3.3 in an area declared or in terms of section 6A(2) of the Act, excluding a stand leased by virtue of a lease agreement as contemplated in Section 4.

### 4. APPLICATION TO LEASE A STAND

4.1 Any person who intend to carry on business as contemplated in 2.3 and 3.3 above shall, on the prescribed form apply to the Council or Hawkers Association authorized to do so, for the lease or allocation of a stand.

4.2 If such application is successful—

- a) the applicant shall, in respect of such stand, enter into a lease agreement with the Council or organization as in 4.1 above, at such rental as prescribed;
- b) proof of the persons right to occupy such stand for a purpose of carrying on business as contemplated in 2.3 shall be issued by the Council or the relevant organization authorised to do so;
- c) the occupants of allocated stands while carrying on business on the stand, retain such proof/permit, ready for inspection to any authorised officer;
- d) the Council may, at the written request of the person afforded the right to occupy his stand in terms of the lease agreement, issue proof to a bona fide vendor who shall be required to provide such proof upon request or demand;

4.3 A person who carries on the business of a street vendor on a stand and who is unable to produce such proof, as contemplated herein above, shall be guilty of an offence in terms of the act and in terms of a Code of Conduct to be applied by the relevant Hawkers Organisation.

### 5. OFFENCES

5.1 A street vendor who—

- a) places or stacks goods on a stand in such a manner that it constitutes a danger or are likely to cause an injury to any person or damage to any other goods or property;
  - b) attaches any goods by means to any building, structure, pavement, tree, parking metre, lamp pole, electricity pole, telephone booth, post box, traffic sign or bench;
  - c) makes a fire on a near any stand
  - d) stores goods in a manhole or stormwater drain;
  - e) disposes of any litter in a manhole, stormwater drain or any other place not intended for the disposal thereof; or
  - f) contravenes any provision of these By-laws and regulations promulgated in terms thereof or fails to comply herewith or with any other condition imposed in terms of these by-laws
- shall be guilty of an offence.

5.2 A street vendor who fails to—

- a) keep an allocated stand, including any good utilised in a business, in a hygienic and neat condition;
  - b) take all reasonably necessary precautions to prevent spilling any litter, including fat, oil and grease, on to a public road;
- or
- c) move his goods after being requested to do so by an authorised officer or an employee of the Council who's duties include the rendering of an essential public service, or is related thereto, in order to permit or facilitate the rending of such essential public service
- shall be guilty of an offence.

**6. IMPOUNDMENT AND REMOVAL**

6.1 Any authorised officer may impound and/or remove any goods—

- a) which he/she reasonably suspects is being used or intended to be used or has been used in connection with the carrying on of the business of street vendor, pedlar or hawker, or are sold in contravention of the applicable Health Regulations;
- b) which he/she finds in a park or a public road and which, in his/her opinion, constitutes an infringement of this, or other by-laws, whether or not such goods are in the possession of or under the control of any person at the time of such removal and/or impoundment;

6.2 a) The authorised officer who acts in terms of subsection (1) above, shall issue a receipt to the person who appears to be in control of the goods concerned.

b) Any goods removed or impounded in terms of subsection 6(1) above, shall be marked in a suitable manner and kept in safe custody pending the institution of criminal proceedings.
