DAAR WORD BEPAAL deur die Provinsiale Wetgewer van die Noordelike Provinsie, as volg:—

Die herroep van wette en besparings

1. (1) Die wette soos genoem in Bylae 1 aan hierdie Wet, is onderhewig aan subartikels (2) en (3), hierdeur herroep.

(2) Enigiets wat gedoen word onder voorsiening van 'n Wet wat herroep is deur subartikel (1), wat moontlik gedoen kan word onder voorsiening van 'n wet genoem in Bylae 2 aan hierdie Wet, sal beskou as gedoen te gewees onder laasgenoemde voorsiening, behalwe wanneer die Premier van die Provinsie anders aandui.

(3) Enige persoon wat 'n welsynspensioen of enige soortgelyke voordeel ontvang onder 'n wet herroep deur hierdie Wetsontwerp, maar wat op grond van die voorwaardes van die Wet op Sosiale Bystand, 1992, nie geregtig is om 'n skenking te ontvang nie, slegs omdat hy of sy nie 'n Suid-Afrikaanse burger is nie, sal nou gesien word as geregtig te wees om sodanige skenking te ontvang, onder laasgenoemde Wet.
