

## DETERMINATION OF THE SALARIES AND ALLOWANCES OF MEMERS OF THE EXECUTIVE COUNCIL AND MEMBERS OF THE PROVINCIAL LEGISLAURE OF THE NORTHERN PROVINCE

In terms of section 6 (3) (a) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) (hereafter referred to as "the Remuneration Act"), I hereby determine the salaries and allowances to be paid annually to Members of the Executive Council and Members of the Provincial Legislature specified in Column 1 of the Schedule and who, for the purpose of this determination, are categorised under the grades specified in Column 1, to be as specified in Column 2 of that Schedule.

In terms of section 6 (4) of the Remuneration Act, I determine the amount of R40 000 per annum as the portion of the remuneration of a Member of the Executive Council and a Member of the Provincial Legislature to which section 8 (1) (d) of the Income Tax Act, 1962 (Act No. 58 of 1962), shall apply.

This Proclamation shall apply with effect from 1 April 1999.

In this Proclamation, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Remuneration Act, the Constitution of the Republic of South Africa, 1996, or the relevant Rules and Orders contemplated in section 116 of the Constitution, bears that meaning.
