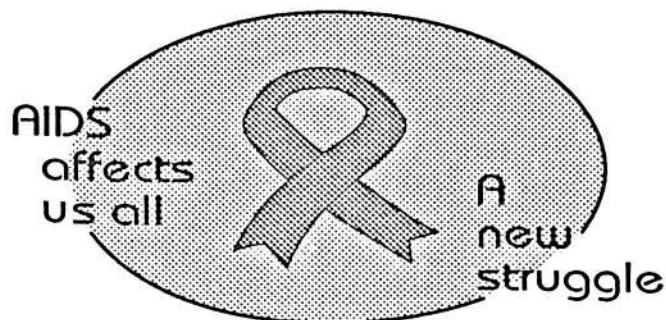

In terms of section 21 of the Local Government: Municipal Demarcation Act, 1998 (Act No.27 of 1998) read with section 155(6A) of the Constitution, 1996 (Act No. 108 of 1996) and section 90 of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998) the Municipal Demarcation Board, has determined the municipal boundaries of category A (metropolitan), category B (local) and category C (district) municipalities extending across provincial boundaries, as reflected in the maps appearing in the Schedule.

Any person aggrieved by the determination may submit objections in writing to the Board. Written objections must be submitted within 30 days after the date of publication of this notice and must be addressed to:

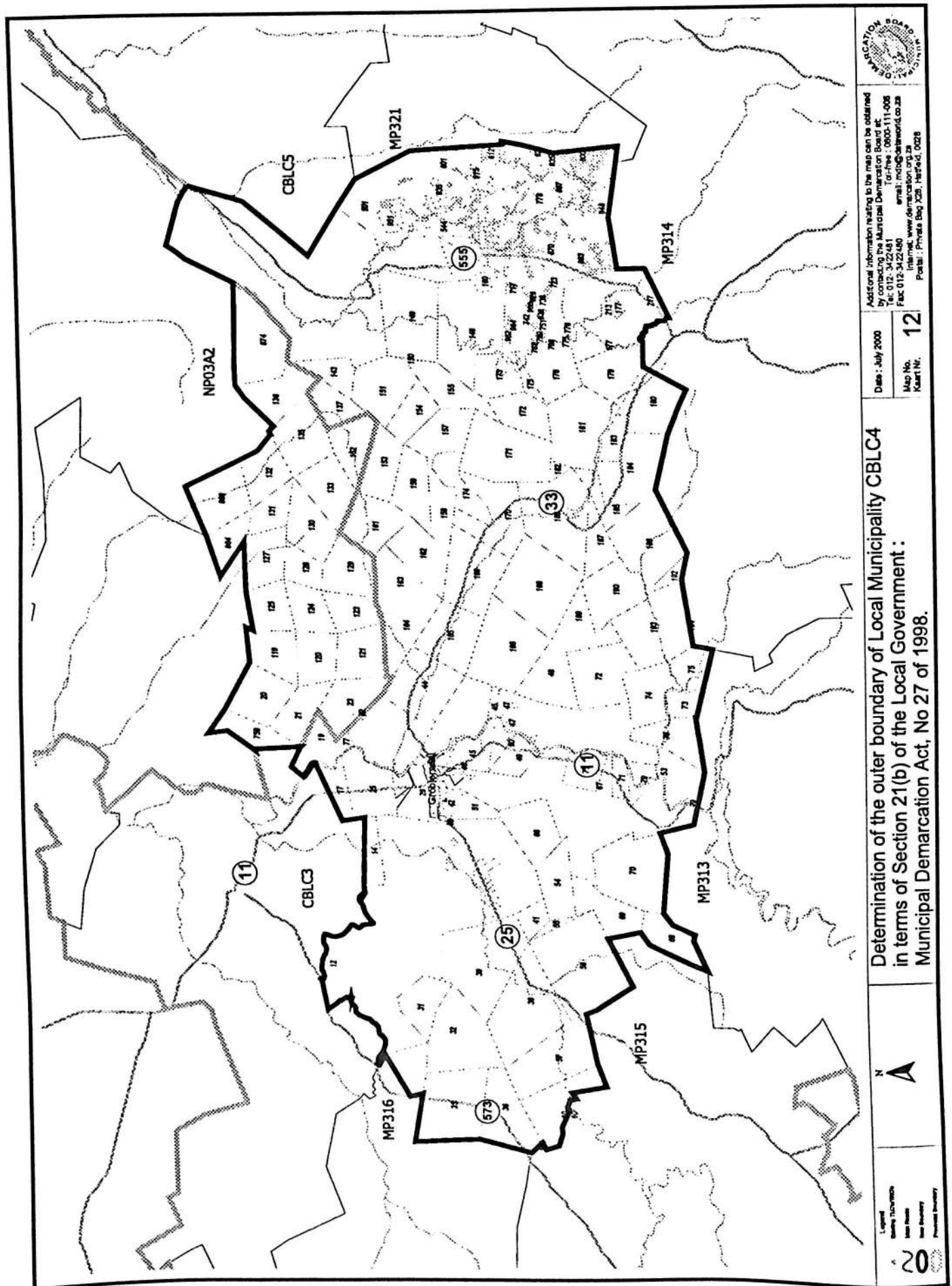

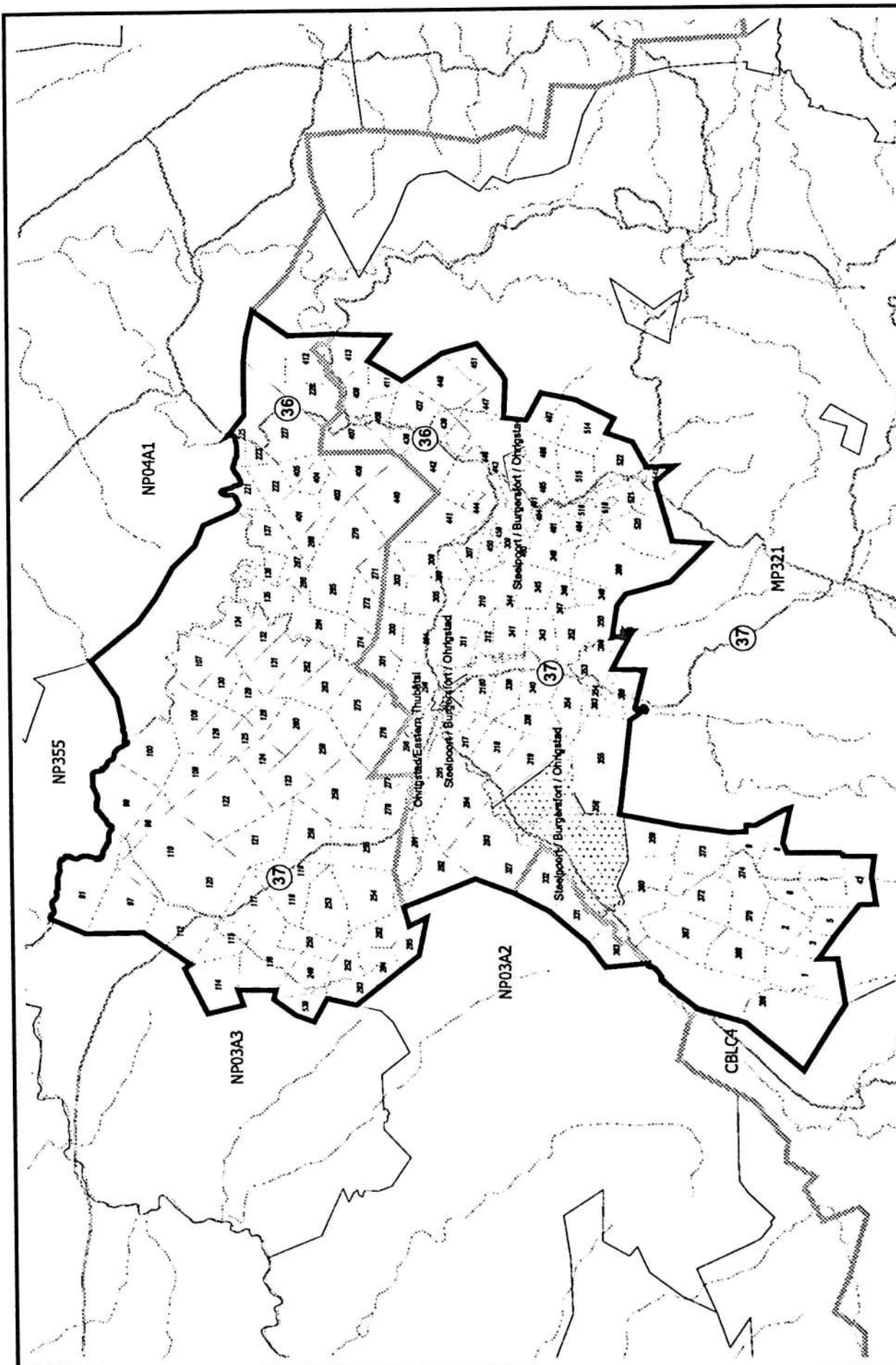
Kaart No. 5 – Kaart van die grense van Oorgrens Distriksmunisipaliteit CBDC3

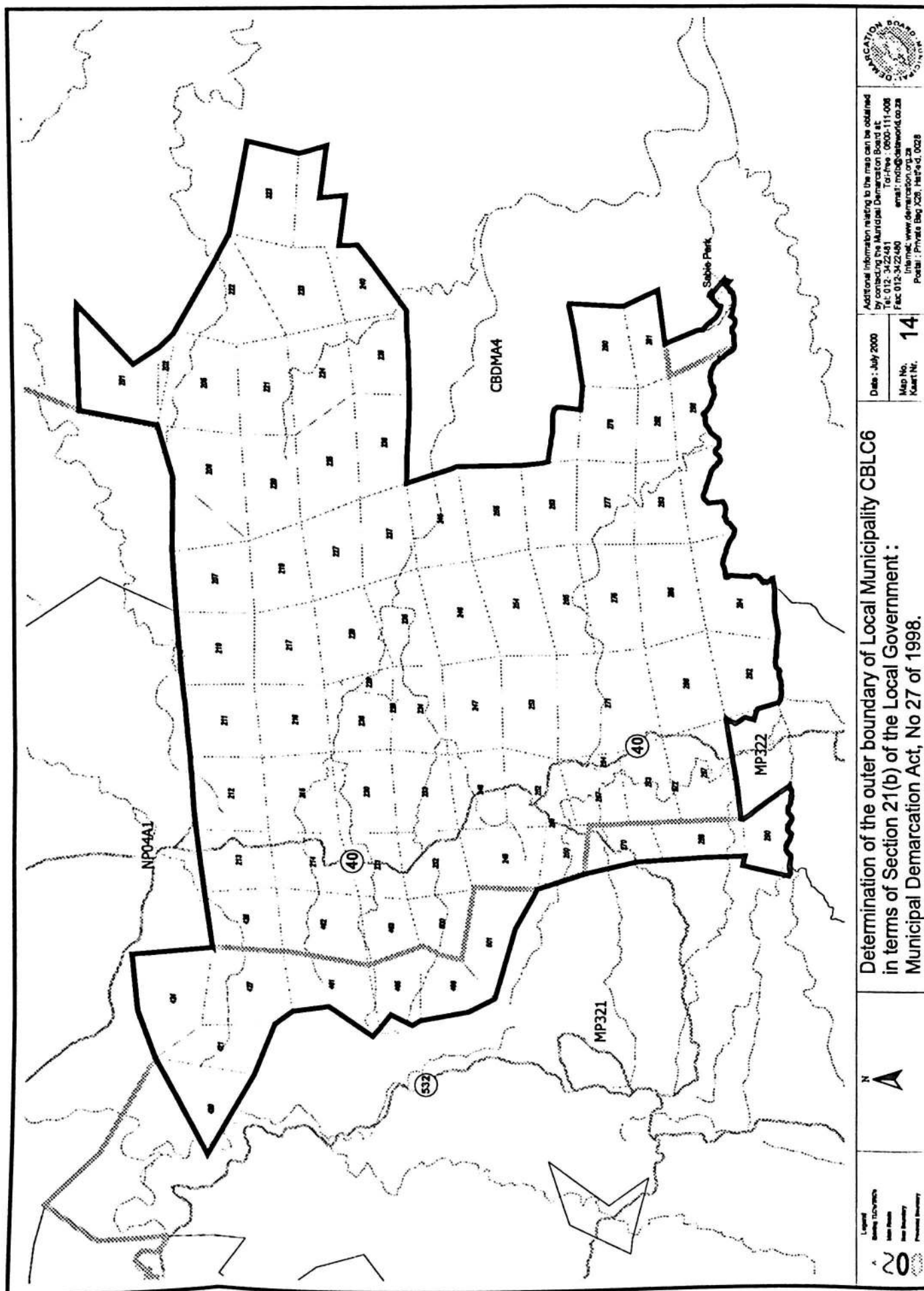
