

No. 3 of 2000: Northern Province Local Government Ordinance Amendment Act, 2000

ACT

To provide for the amendment of section 50 of the Local Government Ordinance (Ordinance 17 of 1939) so as to exclude the application of subsection (1) of the Ordinance to the first transfer of land to a purchaser; and to provide for matters incidental thereto.

BE IT ENACTED by the Legislature of the Northern Province, as follows—

Amendment of section 50 of Ordinance 17 of 1939

1. Section 50 of the Ordinance is hereby amended by the insertion after subsection (1) of the following subsection:

“(1A) The provisions of subsection (1) shall not apply to the first transfer of land to a purchaser who—

- (a) is the first purchaser of a dwelling erected in terms of the Development and Housing Act, 1985 (Act No. 103 of 1985);
- (b) is the first purchaser of a dwelling erected in terms of the Housing Act (House of Representatives), 1987 (Act No. 2 of 1987);
- (c) is the first purchaser of a property erected in terms of the Housing Development Act (House of Delegates), 1987 (Act No. 4 of 1987);
- (d) was the first purchaser of a property erected in terms of the Housing Act, 1966 (Act No. 4 of 1966); or
- (e) was the first purchaser of a property erected in terms of Housing Act, 1997 (Act No. 107 of 1997);

Provided that satisfactory arrangement for the payment of any amount due in terms of subsection (1) have been concluded between the purchaser and the relevant Council.

It is hereby notified that the Premier has assented to the following Act which is hereby published for general information:—

No. 4 of 2000: Northern Province Determination of Types of Municipality Act, 2000

ACT

To determine types of municipality that may be established in the Northern Province; and to provide for matters in connection therewith

PREAMBLE

WHEREAS section 155(1) of the Constitution defines the different categories of municipality that may be established;

AND WHEREAS section 155(2) of the Constitution requires national legislation to define the different types of municipality that may be established within each category of municipality;

AND WHEREAS Part 2 of Chapter 1 of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), in compliance with section 155 (2) of the Constitution, has defined the different types of municipality that may be established within each category of municipality;

AND WHEREAS section 155(5) of the Constitution requires provincial legislation to determine which of the defined types of municipality may be established in the Province;

BE IT THEREFORE ENACTED by the Legislature of the Northern Province, as follows:—

Definitions

1. In this Act, unless the context otherwise indicates, a word or expression to which a meaning has been assigned in the Local Government: Municipal Structures Act 1998 (Act No. 117 of 1998), has a similar meaning, and—

“category” in relation to municipalities, means a category B or C municipality as defined in section 155(1) of the Constitution;

“collective executive system” means a system of municipal government that allows for the exercise of executive authority through an executive committee in which the executive leadership of the municipality is collectively vested;

"constitution" means the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996);

"mayoral executive system" means a system of municipal government which allows for the executive authority through an executive mayor in whom the executive leadership of the municipality is vested and who is assisted by a mayoral committee;

"Member of Executive Council" means the Member of the Executive Council responsible for the local government matters in the Province;

"plenary executive system" means a system of municipal government which limits the exercise of the executive authority to the municipal council;

"Province" means Northern Province referred to in section 103(1)(g) of the Constitution;

"sub-council participatory system" means a system of municipal government which allows for delegated powers to be exercised by subcouncils established for parts of the municipality; and

"ward participatory system" means a system of municipal government which allows for matters of local concern to wards, to be dealt with by committees established for wards.

Category B municipalities

2. In category B the following types of municipality may be established in the Province:

- (a) A municipality with a collective executive system;
- (b) a municipality with a collective executive system combined with a ward participatory system;
- (c) a municipality with a mayoral executive system;
- (d) a municipality with a mayoral executive system combined with a ward participatory system;
- (e) a municipality with a plenary executive system; and
- (f) a municipality with a plenary executive system combined with a ward participatory system.

Category C municipalities

3. In category C the following types of municipality may be established in the Province:

- (a) A municipality with a collective executive system;
- (b) a municipality with a mayoral executive system; and
- (c) a municipality with a plenary executive system.

Provincial Government bound by this Act

4. This Act binds the Member of the Executive Council responsible for Local Government when—

- (a) determining the type of a municipality to be established in terms of section 12 of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998);
- (b) changing the municipality from one type to another in terms of section 16 of that Act; or
- (c) amending or replacing an establishment notice in terms of section 17 of that Act.

Short title and commencement

5. This Act is called the Northern Province Determination of Types of Municipality Act, 2000.

NOU DERHALWE BEPAAL die Proviniale Wetgewer van die Noordelike Provinsie, soos volg:

Woordomskrywings

1. In hierdie Wet, tensy dit anders uit die samehang blyk, beteken, dit dat 'n woord of uitdrukking waaraan betekenis gegee is in die Plaaslike Regering; Wet op Munisipale Strukture, 1998 (Wet 117 van 1998), 'n soortgelyke betekenis het, en dat—

“**burgemeesters uitvoerende bestuurstelsel**”, 'n stelsel van munisipale regering waar die gesagsvoering by 'n uitvoerende burgemeester as die uitvoerende leierskap van die munisipaliteit, berus en wat deur 'n burgemeesterskomitee, bygestaan word;

“**gesamentlike uitvoerende bestuurstelsel**”, 'n stelsel van munisipale regering wat vir die beoefening van uitvoerende gesag deur 'n uitvoerende komitee, waarin die uitvoerende leierskap van die munisipaliteit gesamentlik berus, toelating maak;

“**grondwet**”, die Grondwet van die Republiek van Suid-Afrika, 1996 (Wet No. 108 van 1996);

“**kategorie**”, in verhouding tot munisipaliteite, 'n kategorie B of C munisipaliteit, soos omskryf in artikel 155(1) van die Grondwet;

“**lid van die Uitvoerende Raad**”, 'n lid van die Uitvoerende Raad verantwoordelik vir die plaaslike regeringaangeleenthede in die Provinsie;

“**Provinsie**”, die Noordelike Provinsie soos na verwys in Artikel 103 (1)(g) van die Grondwet;

“**sub-raad deelnemende bestuurstelsel**”, 'n stelsel van munisipale regering wat vir gedelegeerde magte wat deur sub-rade wat as deel van die munisipaliteit ingestel is, beoefen kan word, toelating maak;

“**volle uitvoerende bestuurstelsel**”, 'n stelsel van munisipale regering wat die beoefening van uitvoerende gesag, beperk tot die munisipaleraad persoonlik;

“**wyks deelnemende bestuurstelsel**”, 'n stelsel van munisipale regering wat voor-siening maak vir sake van plaaslike belang in wyke en wat hanteer word deur komitees ingestel vir wyke.

Kategorie B munisipaliteite

2. In kategorie B mag munisipaliteite van die volgende aard in die provinsie gevestig word:

- (a) 'n Munisipaliteit met 'n gesamentlike uitvoerende bestuurstelsel;
- (b) 'n munisipaliteit met 'n gesamentlike bestuurstelsel, gekombineer met 'n wyks deelnemende bestuurstelsel;
- (c) 'n munisipaliteit met 'n burgemeesters uitvoerende bestuurstelsel;
- (d) 'n munisipaliteit met 'n burgemeesters uitvoerende bestuurstelsel, gekombi-neer met 'n wyks deelnemende bestuurstelsel;
- (e) 'n munisipaliteit met 'n volle uitvoerende bestuurstelsel; en
- (f) 'n munisipaliteit met 'n volle uitvoerende bestuurstelsel, gekombineer met 'n wyks deelnemende bestuurstelsel.

Kategorie C munisipaliteit

3. In kategorie C mag munisipaliteit van die volgende aard in die provinsie gevestig word:

- (a) 'n Munisipaliteit met 'n gesamentlike uitvoerende bestuurstelsel;
- (b) 'n munisipaliteit met 'n burgemeesters uitvoerende bestuurstelsel; en

ACT

To provide for the rationalisation of laws relating to Local Government applicable in the Northern Province; to provide for the repeal and amendment of certain such laws; to extend the application of certain laws of the whole Province; and for matters incidental thereto

*(English text signed by the Premier)
(Assented to on 5 July 2000)*

BE IT ENACTED by the Legislature of the Northern Province, as follows—

Repeal and amendment of laws

1. The laws mentioned in Schedule 1 are repealed and the laws mentioned in Schedule 2 are amended to the extent indicated in the third column of the said Schedules.

Wider application of laws

2. The following laws apply in the whole area of the Northern Province:

- (a) The Civil Defence Ordinance, 1977 (Ordinance 20 of 1977), as amended and the Regulations on Civil Defence published in terms of that Ordinance by Administrator's Notice No. 1884 of 15 December 1978; and
- (b) the Pounds Ordinance, 1972 (Ordinance 13 of 1972) and the Pounds Regulations published in terms of that Ordinance by Administrator's Notice No. 2279 of 20 December 1972.

Transitional provisions

3. Anything purportedly done in good faith under a provision of a law repealed by section 1, or deemed to have been so done under a repealed law, and which may be done under a corresponding provision of the Civil Defence Ordinance, 1977, or Pounds Ordinance, 1972, is deemed to have been done under that corresponding provision.
