

REGULATIONS

The MEC responsible for Sport, Arts & Culture in the Northern Province, has in terms of sections 23, 26 and 49 of the National Heritage Resources Act, 1999 (Act No. 25 of 1999), promulgated the regulations contained in the Schedule hereto.

10. Administrative functions of Council
11. Delegation of functions and powers of Limpopo Heritage Authority
12. Appeals

1. Definitions

(1) In these regulations any word or expression, which has been defined in the National Heritage Resources Act, 1999 (Act No. 25 of 1999), shall have the same meaning assigned to that word or expression in that Act.

(2) Unless the context otherwise indicates-

"Council" means the Council of the Limpopo Heritage Resources Authority appointed in terms of regulation 3;

"Department" means the department responsible for heritage matters in the Province;

"LHA" means the Limpopo Heritage Authority;

“MEC” means Member of the Executive Council responsible for heritage matters in the Province; and

“the Act” means the National Heritage Resources Act, 1999 (Act No. 25 of 1999).

2. Establishment of Limpopo Heritage Authority

- (1) The Limpopo Heritage Authority is hereby established.
- (2) The LHA is responsible for the management of heritage resources within the Province and shall be governed by a Council constituted in terms of these regulations.

3. Constitution of Council of LHA

- (1) The MEC must invite the general public to nominate persons for appointment as members of the Council.
- (2) Once such nominations have been received, the MEC must appoint-
 - (a) a panel to compile a shortlist of candidates from the nominees; and
 - (b) the Council from the shortlist of candidates submitted in accordance with the principles of transparency and representivity and with due consideration of the following requirements-
 - (i) cost-effectiveness and efficiency;
 - (ii) effective administration and service rendering;
 - (iii) capacity in the specific categories of heritage resources to be managed in the province; and
 - (iv) cultural, geographical and demographical considerations.
- (3) Members of the Council must-
 - (a) be South African citizens;
 - (b) be permanently resident in the Province; and

- (c) represent a broad range of experience, expertise and skills on the Council, including-
- (i) archaeology;
 - (ii) architecture;
 - (iii) living culture;
 - (iv) palaeontology;
 - (v) financial management;
 - (vi) law;
 - (vii) social history;
 - (viii) urban planning; and
 - (ix) traditional practises/indigenous knowledge systems.
- (4) The Council shall consist of at least nine, but not more than 14 members as may be determined by the MEC.
- (5) A member of the Council must vacate office if the member-
- (a) resigns in writing;
 - (b) has been absent from three consecutive meetings the Council without leave;
 - (c) has been declared an unrehabilitated insolvent by a court of law;
 - (d) is found to be of unsound mind by a court of law; or
 - (e) is convicted of an offence involving dishonesty or violence.
- (6) The term of office of members of Council is three years: Provided that no member may serve more than two consecutive terms in the Council.
- (7) The MEC must appoint new members to serve in the Council from the date on which the term of office of existing members of the Council expires.
- (10) The MEC may remove a member of the Council from office if in the opinion of the MEC, there are reasonable grounds to do so.
- (11) If a member of the Council dies, vacates office, or becomes incapable to perform Council duties before expiry of the term of office, another person may be appointed to fill the vacancy for the unexpired period for which the member was appointed.

4. Finances

- (1) The Department must provide funds to the LHA from moneys appropriated by the Provincial Legislature to enable the Council to perform Council functions and duties as prescribed in the Act.
- (2) All financial arrangements of the LHA must comply with the Public Finance Management Act, 1999 (Act No.1 of 1999).
- (3) The Council shall be the accounting authority of the LHA as envisaged in section 49(2)(a) of the Public Finance Management Act, 1999 (Act No.1 of 1999).

5. Chairperson of Council

- (1) The MEC must appoint the Chairperson of the Council from the Council members.
- (2) The Chairperson holds office for the period or the unexpired portion of the period for which the Chairperson is appointed as a member of the Council, unless the MEC determines otherwise.
- (3) If, for whatever reason, the Chairperson vacates office before the expiry of the period for which the Chairperson is appointed, the MEC shall appoint another member of the Council as Chairperson for the unexpired portion of the term.
- (4) If the Chairperson is absent from a meeting of the Council or not able to preside at that meeting, the members present must elect one of the members present to preside at that meeting.

6. Committees of Council

- (1) The Council may-
 - (a) establish Committees to assist the Council in the performance of the Council functions; and
 - (b) appoint to such Committees persons who are non-Council members whom Council considers competent or who possess specific skills and expertise.
- (2) The Council must appoint Chairpersons of the Council's Committees.

- (3) A Chairperson of a Committee must vacate office if that Chairperson has been absent from three consecutive Committee meetings without a reasonable excuse acceptable to Council.
- (4) In the case of an Appeal Committee, the Council may appoint additional persons on the basis of such additional person's qualifications and expertise in, or knowledge of heritage resources management, to assist the Committee in considering appeals.


7. Declaration of interest of members of Council or Council's Committees

- (1) A member of Council or any of the Council's Committees must declare any interest the member might have in relation to a matter the Council or the Council's Committees has to consider.
- (2) The members referred to in subsection (1) must not participate in the discussions and recommendations or decisions of Council or Council's Committees concerning that particular matter.

8. Meetings of Council and Council's Committees

- (1) The Council must determine the Council's own internal arrangements, proceedings and procedures and those of Council's Committees by laying out rules for the-
 - (a) convening of meetings;
 - (b) procedure at meetings; and
 - (c) frequency of meetings: Provided that the Council must meet at least four times per year.
- (2) A quorum for a meeting of the Council or Council's Committees is a simple majority of the appointed members.
- (3) Decisions of the Council are taken by resolution of a majority of all the members present at a meeting of the Council. In the event of an equality of votes on any matter, the person presiding at the meeting in question shall, in addition to the member's deliberate vote as a member of the Council, have a deciding vote.

- (4) In considering an appeal, the Appeal Committee must have due regard to-
- (a) the significance of the heritage resource in question;
 - (b) the principles set out in section 5 of the Act; and
 - (c) any other relevant factor brought to the attention of the Appeal Committee by the appellant, the LHA or any other person or body directly affected by the decision.
