## LIMPOPO LOCAL GOVERNMENT LAWS RATIONALISATION AMENDMEND BILL, 2004

To rationalize the local government laws applicable to the Province of Limpopo that became obsolete as a result of the local government laws that were enacted since 1994; to provide for the repeal and amendment of laws and to provide for matter connected therewith.

BE IT ENACTED by the provincial legislature of Limpopo, as follows:-

#### Repeal and amendment of Laws

1. The laws specified in the first column of the Schedule are hereby repealed to the extent indicated in the second column of the Schedule.

#### Short title

2. This Act is called the Limpopo Local Government laws Rationalisation Amendment Act, 2004.
