

It is hereby notified that the Premier has assented to the following Act which is hereby published for general information:—

No. 1 of 2005: Limpopo Tender Board Repeal Act, 2005.

**ACT**

**To provide for the repeal of the Northern Transvaal Tender Board Act, 1994(Act No. 2 of 1994); the dissolution of the Northern Transvaal Tender Board; and to provide for matters incidental thereto.**

**PREAMBLE**

WHEREAS section 187 of the Interim Constitution provided for provincial laws to regulate the procurement of goods and services and for the appointment of independent and impartial tender boards to deal with that procurement; and

WHEREAS the Provincial Legislature accordingly enacted the Northern Transvaal Tender Board Act, 1994 and, amongst others, established the Northern Transvaal Tender Board;

AND WHEREAS Parliament pursuant to section 216 of the Constitution of the Republic of South Africa, 1996 has enacted the Public Finance Management Act, 1999 which includes provisions which supercede the previous provincial procurement dispensation rendering provincial tender board laws and provincial tender boards redundant.

THEREFORE BE IT ENACTED by the Provincial Legislature of Limpopo, as follows:

**Definitions**

1. In this Act, unless the context indicates otherwise—

“Tender Board” means the Northern Transvaal Tender Board established by section 3 of the Northern Transvaal Tender Board Act, 1994 (Act No. 2 of 1994); and

“the Tender Board Act” means the Northern Transvaal Tender Board Act, 1994 (Act No. 2 of 1994).

#### **Dissolution of Tender Board**

2. The Tender Board is hereby dissolved.

#### **Repeal of Tender Board Act**

3. The Tender Board Act is hereby repealed.

#### **Savings**

4. (1) Despite the dissolution of the Tender Board in terms of section 2, the Tender Board must continue to function for the purposes of finalizing matters outstanding at the date of commencement of this Act: Provided that the Tender Board must finalize all such cases within 90 days of commencement of this Act.
- (2) Anything done in terms of a provision of the Tender Board Act, shall be deemed to have been done under a corresponding provision of the Public Finance Management Act, 1999 (Act No. 1 of 1999), the regulations promulgated and the Treasury instructions issued in terms of the Public Finance Management Act, 1999 (Act No. 1 of 1999).
- (3) Rights and obligations resulting from any action of the Tender Board, which action was exercised in accordance with the powers given to the Tender Board in terms of the Tender Board Act, vest in the department on behalf of which the Tender Board exercised the said powers.

#### **Short title and commencement**

5. This Act is called the Limpopo Tender Board Repeal Act, 2005, and comes into operation on a date determined by the Premier in the *Gazette*.

Om voorsiening te maak vir die herroep van die Noord Transvaal Wet op die Tenderraad, 1994 (Wetnr 2 van 1994); en die ontbinding van die Noord Transvaal Tenderraad en om voorsiening te maak vir aangeleenthede wat daarmee verband hou.

**INLEIDING**

**AANGESIEN** Seksie 187 van die Tussentydse Grondwet voorsiening maak vir provinsiale wette vir die regulering van die verskaffing van goedere en dienste en vir die aanstelling van 'n onafhanklike en onpartydige Tenderraad om hierdie verskaffings te hanteer;

**AANGESIEN** die Provinciale Wetgewer die Noord Transvaal Wet op die Tenderraad, 1994 ooreenstemmend bepaal, en onder andere, is die Noord Transvaal Wet op die Tenderraad ingestel;

**EN AANGESIEN** die Parlement ingevolge seksie 216 van die Wet op Openbare Administrasie, 1999 van die Grondwet van die Republiek van Suid-Afrika, 1996 gemagtig is, en bepalings insluit wat die vorige provinciale verskaffing en verspreidingdiens provinsiale Tenderraad en die provinciale Tenderraad oorbodig maak.

Ooreenstemmend word dit soos volg gemagtig deur die Provinciale Wetgewer van Limpopo;—

**Woordomskrywing**

1. In hierdie Wet, tensy die verband anders aandui, beteken —

“Tenderraad” die Noord Transvaalse Tenderraad, ingestel kragtens seksie 3 van die Noord Transvaal Wet op die Tenderraad, 1994 (Wetnr 2 van 1994)

“Die Tenderraad Wet” die Noord Transvaal Wet op die Tenderraad, 1994 (Wetnr 2 van 1994)

“Ontbinding van Tenderraad”

2. Die Tenderraadword hiermee ontbind.

Herroep van die Wet op die Tenderraad

3. Die Wet op die Tenderraad word hiermee herroep.

**Uitgesluit.**

4. (1) Ten spyte van die herroep van die Tenderraad kragtens seksie 2, moet die Tenderraad voortgaan met sy funksies vir die doel om aangeleenthede te finaliseer wat uitstaande is sedert die aanvangs van die Wet; met dien verstande dat die Tenderraad alle aangeleenthede moet finaliseer binne 90 dae vanaf die aanvangs van die Wet.  
  
(2) Enige iets gedoen kragtens 'n bepaling van die Wet op die Tenderraad sal beskou word as gedoen kragtens 'n ooreenstemmende bepaling van die Wet op Openbare Finansiële Bestuur, 1999 (Wetnr 1 van 1991), die regulasies bekend gemaak en die Finansiële instruksies uitgereik kragtens die Wet op Openbare Finansiële Bestuur, 1999 (Wetnr 1 van 1999)  
  
(3) Reëls en verpligtinge wat voortspruit uit enige aksie van die Tenderraad, wie se gesag uitgeoefen word in ooreenstemming met die magte aan die Tenderraad gegee kragtens die Wet op die Tender Raad, gee aan die department die mag om namens die Tenderraad gesag uit te oefen.

**Kort Titel en Voortsetting**

5. Hierdie Wet staan bekend as die Limpopo Wet op die Herroep van Tenders, 2005, en word van krag op 'n datum soos bepaal deur die Premier in die Koerant.
