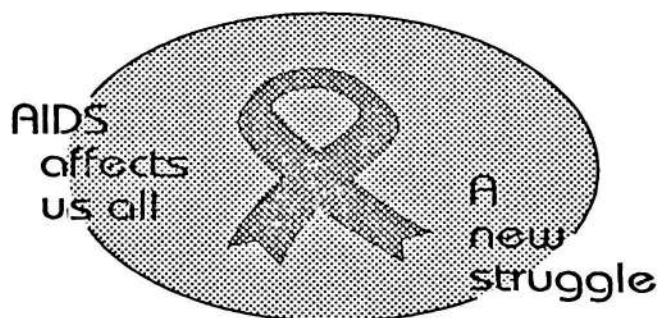

No. 3 of 2005: **Limpopo Unauthorised Expenditure Act, 2005**

ACT

To authorize certain unauthorized expenditure; to charge the Provincial Revenue Fund accordingly; and to provide for matters connected therewith.

(English text signed by the Premier)
(Assented to on 24-10-2005)

BE IT ENACTED by the Provincial Legislature of Limpopo, as follows: —

Authorization of unauthorized expenditure 1995/96, 1996/97, 1997/98 and 1998/99 financial years

1. (1) The Provincial Revenue Fund is charged with the amount of R1 842 588 000 to authorize certain unauthorized expenditure as set out in Schedule 1 for the 1995/96, 1996/97, 1997/98 and 1998/99 financial years, over and above the amounts appropriated for this service for the financial years which ended on 31 March 1996, 1997, 1998 and 1999.
- (2) The expenditure referred to in subsection (1) is fully described in the Report of the Auditor-General as reflected in Schedule 1.
- (3) The expenditure is a direct charge against the Provincial Revenue Fund.

Action of recovery of unauthorized expenditure

2. Nothing in this Act may in any way be construed as affecting any action to recover unauthorized expenditure.

Short title

3. This Act is called the Limpopo Unauthorized Expenditure Act, 2005.
