Communication Purpose

This report is compiled in compliance with Section 47 of Chapter 6 of the Municipal Systems Act (2000) that obliges municipalities to monitor its performance in order to measure, review, evaluate and to improve its performance at organizational as well as at individual level. The MEC for local government has the mandate to monitor the overall performance of the municipalities in order to identify areas to strengthen the capacity of municipalities.

The Municipal Systems Act Subsection 46(1), obliges a municipality to prepare for each financial year a performance report reflecting the following:

- The performance of the municipality and of each external stakeholder during that financial year.
- A comparison of the performances referred to in (a) with targets set for and performances of the previous financial year.
- Measures taken to improve performance.

Section 47 stipulates that the MEC for Local Government must annually compile and submit to the provincial legislature and the Minister a consolidated report on the performance of municipalities in the province.

The MEC for Local Government must submit a copy of the report to the National Council of Provinces. The report must:

EXECUTIVE SUMMARY

REPORTING SCOPE

The report is anchored on the five year Local Government Strategic Agenda which has five pillars, i.e

- Institutional Transformation and Development
- Basic service delivery and infrastructure development
- Local Economic Development
- Financial Viability and Management
- Good governance and Public Participation

INSTITUTIONAL TRANSFORMATION AND DEVELOPMENT

FILLING OF TOPMANAGEMENT POSTS

The Municipal System Act (2000) Section 56 obliges municipal council to priorities the appointment of Municipal Manager as an accounting officer nd those managers reporting to the municipal manager. Therefore the filling of top managers have been monitored over the past three years and the assessment of the provincial status shows that the filling of total posts has always been a major challenge in the province, however remarkable progress has been made as follows:

- Municipal Managers: filling of MM has improved from 83%, in 2006/7 to 97% in 2008/09fy
- Chief Financial Officers: filling of CFOs post has been stable at 87% over the past three years
- Technical Managers: filling of TM has improved from 87% in 06/07 to 93% in 2008/09.

This improved is further more evident at the district level as follows:

- The filling of Municipal Managers posts has improved to100% in all districts except for Waterberg,
- The filling of CFOs has improved for all districts except Waterberg and Sekhukhune.
- The filling of Technical Managers has improved drastically in Waterberg and Greater Sekhukhune although the district did not record 100%. All districts have maintained stability in this regard.

The employment of women in top management posts in municipalities has decreased substantial from 32% in 07/08 to 26% in 08/09 fy. The decline is noted in all districts except for Capricorn which recorded an improvement from 16% in 07/08 to 28% in 08/09. The employment of women in all categories except section 57 has decreased from 43% in 07/08 to 37% in 08/09, which is almost the same as 06/07 at 38%. The most notable decrease is in Waterberg from 45% in 07/08 to 26% in 08/09 fy, also Sekhukhune from 44% in 07/08 to 20% in 08/09 fy. Vhembe district has shown a substantial improvement from 29% in 07/08 to 43% in 08/09

IMPLEMENTATION OF PERFORMANCE MANAGEMENT SYSTEM

The signing and submission of performance agreements has improved from 80% in 06/07 to 90% in 08/09 financial year. The challenges were in the main experienced in Waterberg. The performance assessment for section 57 improved from 10% in 06/07 to 47% in 08/09 financial year. Progress was recorded in Mopani at 100% and the least performed districts are Waterberg (14%), Sekhukhune (33%) whilst Capricorn recorded 50%. It should also be noted that municipalities which conducted their section 57 performance assessment did not submit minutes or assessment reports to the MEC, as enshrined in the Regulations 2006. Only Fetakgomo has complied with this requirement.

• The submission of annual and mid-year reports sustained 100% rate in all municipalities in the province. Although some municipalities delayed the adoption of the section 46 reports, there was noticeable improvement.

 The challenge experienced is with regard to the submission of oversight reports. Mopani achieved 100% submission followed by Sekhukhune 67%, Capricorn 50% and the least performing are Vhembe 20% and Waterberg 14% respectively.

FINANCIAL VIABILITY AND MANAGEMENT

MUNICIPAL AUDIT REPORTS HIGHLIGHTS

- Bad audit reports: 15(50%) municipalities received disclaimers and there is no adverse audit report. The number of municipalities with disclaimer reports has decreased from 19(63%) in 07/08.
- Unqualified / Clean audit reports: 8(27%) municipalities received unqualified audit reports. This is an improvement compared to 3(10%) in 07/08.
- There is also a great improvement on municipalities that received qualified audit reports as 7(23%) received qualified compared to 5(17%) in 07/08.

GENERAL MFMA COMPLIANCE

- All municipalities have functional Audit Committees and internal audit functions. Elias Motsoaledi has outsourced the internal audit function.
- Municipalities in Mopani and Greater Sekhukhune are utilizing the shared service with the districts.
- 21/25 (84%) of municipalities are implementing the Municipal Property Rates Act.
- All municipalities have submitted their 07/08 financial statements in time except the delay in Makhuduthamaga and Molemole.
- 2/25 (8%) municipalities have not developed their revenue enhancement strategies.
- All municipalities have spend 100% on MIG except 4/30 (13%), Fetakgomo (59%), Ephraim Mogale; (95%), Ba-Phalaborwa (84%) and Blouberg (91%).
- The provincial expenditure is 99%.

GOOD GOVERNANCE AND PUBLIC PARTICIPATION

- 512 wards committees were established. All municipalities have budgeted for the activities of ward committees as compared to the previous financial year where only eighteen were able to finance the activities of ward committees.
- All municipalities have been allocated Community Development Workers by the Office of the Premier. The challenges were the varying level of capacity of the CDW. Therefore the capacity building programme for ward committees became a critical component of achieving substantive public participation.
- The functionality of IGR structures varies from one district to the other; however only two districts (Mopani and Capricorn) have functional IGR structures.

 All districts have developed the Disaster Management Framework.

The MEC for local government has the mandate to monitor the overall performance of the municipalities in order to identify areas to strengthen the capacity of municipalities.

The Municipal Systems Act Subsection 46(1), obliges a municipality to prepare for each financial year a performance report reflecting the following:

- The performance of the municipality and of each external stakeholder during that financial year.
- A comparison of the performances referred to in (a) with targets set for and performances of the previous financial year.
- Measures taken to improve performance.

Section 47 stipulates that the MEC for Local Government must annually compile and submit to the provincial legislature and the Minister a consolidated report on the performance of municipalities in the province.

The MEC for Local Government must submit a copy of the report to the National Council of Provinces. The report must:

- Identify municipalities that underperformed during the year,
- Propose remedial action to be taken,
- Be published in the provincial gazette.

Furthermore, in order to consolidate the report at national level the Municipal Systems Act (2000) Section 48 (1) requires that the Minister for Local Government must annually compile and submit to Parliament and the MECs for Local Government a consolidated report of Local Government performance in terms of general key performance indicators. Subsection (2) requires the report to be published in the gazette.

METHODOLOGY

The primary source of data utilized in this report is the municipal annual performance report compiled in compliance with section 46 of the Municipal Systems Act.

In addition to the municipal annual performance report the department utilized secondary data to complement the municipal performance report, namely

- Municipal quarterly, and mid year performance reports submitted to the department;
- Local Government Strategic Agenda reports as they have been submitted to the Premier Intergovernmental Forum;
- Programme performance reports from the departments, Municipal Infrastructure Grant reports,
- Municipal Turn Around strategies

REPORTING SCOPE

The Five Key Performance Areas:

- Key Performance Area 1: Municipal Transformation and Institutional Development: In essence this focus area measures the extent at which the administrative and overall management capacity is develops, with special emphasis on organizational design and human resources capacity, employment equity, capacity for strategic planning in the form of the IDP and performance management within the municipality;
- II. Key Performance Area 2: Basic Service Delivery and Infrastructure Development: the focus is on accelerating basic service delivery in order to reduce municipal service delivery backlog and as well as on the ability of the local government to develop infrastructure that will sustain the provision of the municipal services. It is measuring whether there is progress towards provision of water and sanitation services, electricity, waste removal, roads and storm water maintenance, as well as the municipalities' state of readiness to deliver housing in partnership with the provincial government. Linked to this is the focuses on the national targets set in line with the Millennium Development Goal as well as the capacity to implement the infrastructure grants projects which are implemented at municipal level through the Municipal Infrastructure Grant.

- Local Economic III. Key Performance Area 3: Development: in this regard the focus is on the strategic intent, and as well as the ability to implement local economic development through an integrating local development opportunities with national and provincial growth and development strategies. The key aspects of the assessment is on measuring whether the municipalities has an approved strategy for the implementation of LED projects, is the sufficient capacity within the municipality to implement LED functions, assessment of poverty alleviation programme and as well as the creation of job through LED initiatives.
- IV. Key Performance Area 4: Financial Viability and Financial Management: the critical elements of this focus area provides an assessment of the extent at which the municipalities develops the capacity to implement the MFMA requirements, the capacity to raise revenue through municipal trading services as well as the capacity for overall budget and expenditure management. Linked to this is the status quo in terms of the Auditor General Reports on the municipality's financial statements.
- V. Key Performance Area 5: Good Governance, Public Participation, Ward Committee: the focus of this area is to assess the running of council, establishment and functionality of the ward committees, assess the extent at which public participation is encouraged, and the level of corporate governance in the municipality.
- VI. Cross Cutting Issues: the report will provide brief overview of the following which cross cutting issues:
 - Presidential / Provincial/ Local Imbizos: the report will provide a review of the progress made with regard to the implementation of the resolutions of the issues raised during either the Presidential/ Provincial or Local Imbizos;
 - Disaster Management: the report will provide a state of institutional readiness in terms of handling disaster incidents in the province;

- Chief Financial Officers: The filling of CFO's posts did not improve as it remained at 50% (3/6) in 08/09.due to vacancies at Fetakgomo, Makhuduthamaga and Marble Hall municipalities.
- Technical Manager: The filling of Technical Managers posts has improved from 50% (3/6) in 07/08 to 83% (5/6) in 08/09 with the exception of Makhuduthamaga where the post has been vacant during the three years under-review.

- Municipal Managers: The filling of MM posts declined from 100% (5/5) in 07/08 to 80% in 08/09 financial year.



CONCLUSION

- The report has shown that there are substantial areas of improvement across the 30 municipalities. The highlight of the overall improvement is recorded in the institutional development key performance area which reflects the overall institutional stability resulting from the improvement in the filling of top management posts. Linked to this is the improvement regarding the compliance with implementation of the performance management system. However the challenge remains with the cascading of PMS to all levels in municipalities.
- There was notable improvement on financial viability and management. The 2008/09 municipal audit reports from the Auditor-General have shown that the state of municipality financial management has improved with 8 municipalities having received unqualified audits. However the concern is that 15 municipalities received disclaimer reports which are 50% of the total municipalities.
- The report has shown a substantial improved in service delivery in general and in particular at the Sekhukhune
 District has improved from the previous financial years, although it still needs urgent attention as it has the highest service delivery backlog.

PURPOSE

To present to the Limpopo Legislature the State of Municipal Report for the 2008/09 fy

BACKGROUND

The Municipal Systems Act Subsection 46(1), obliges a municipality to prepare for each financial year a performance report reflecting the following:

- The performance of the municipality and of each external stakeholder during that financial year.
- A comparison of the performances referred to in (a) with targets set for and performances of the previous financial year.
- Measures taken to improve performance.

Section 47 stipulates that the MEC for Local Government must annually compile and submit to the provincial legislature and the Minister a consolidated report on the performance of municipalities in the province.

The MEC for Local Government must submit a copy of the report to the National Council of Provinces. The report must:

- Identify municipalities that underperformed during the year,
- Propose remedial action to be taken,
- Be published in the provincial gazette.

DISCUSSION

The tabling of this year report comes at the time when the local government sector has been going through substantial policy and programme reviews process which had an impact in the timing of the submission. This is a period charecterised of a robust process of implementing the Local Government Turnaround Strategies across all 30 municipalities. Following below is the executive summary of the report.

REPORTING SCOPE

The report is anchored on the five year Local Government Strategic Agenda which has five pillars, i.e

- Institutional Transformation and Development
- Basic service delivery and infrastructure development
- Local Economic Development
- Financial Viability and Management
- Good governance and Public Participation

INSTITUTIONAL TRANSFORMATION AND DEVELOPMENT

FILLING OF TOPMANAGEMENT POSTS

The Municipal System Act (2000) Section 56 obliges municipal council to priorities the appointment of Municipal Manager as an accounting officer nd those managers reporting to the municipal manager. Therefore the filling of top managers have been monitored over the past three years and the assessment of the provincial status shows that the filling of total posts has always been a major challenge in the province, however remarkable progress has been made as follows:

- Municipal Managers: filling of MM has improved from 83%, in 2006/7 to 97% in 2008/09fy
- Chief Financial Officers: filling of CFOs post has been stable at 87% over the past three years
- Technical Managers: filling of TM has improved from 87% in 06/07 to 93% in 2008/09.

This improved is further more evident at the district level as follows:

- The filling of Municipal Managers posts has improved to100% in all districts except for Waterberg,
- The filling of CFOs has improved for all districts except Waterberg and Sekhukhune.

The filling of Technical Managers has improved drastically in Waterberg and Greater Sekhukhune although the district did not record 100%. All districts have maintained stability in this regard.

The employment of women in top management posts in municipalities has decreased substantial from 32% in 07/08 to 26% in 08/09 fy. The decline is recorded in all districts except for Capricorn which recorded an improvement from 16% in 07/08 to 28% in 08/09. The employment of women in all categories except section 57 has decreased from 43% in 07/08 to 37% in 08/09, which is almost the same as 06/07 at 38%. The most notable decrease is in Waterberg

IMPLEMENTATION OF PERFORMANCE MANAGEMENT SYSTEM

The signing and submission of performance agreements has improved from 80% in 06/07 to 90% in 08/09 financial year. The challenges were in the main experienced in Waterberg. The performance assessment for section 57 improved from 10% in 06/07 to 47% in 08/09 financial year. Progress was recorded in Mopani at 100% and the least performed districts are Waterberg (14%), Sekhukhune (33%) whilst Capricorn recorded 50%. It should also be noted that municipalities which conducted their section 57 performance assessment did not submit minutes or assessment reports to the MEC, as enshrined in the Regulations 2006. Only Fetakgomo has complied with this requirement.

- 21/25 (84%) of municipalities are implementing the Municipal Property Rates Act.
- All municipalities submitted their 07/08 financial statements in time except the delay in Makhuduthamaga and Molemole.
- 2/25 (8%) municipalities have not developed their revenue enhancement strategies.
- All municipalities spend 100% on MIG with the exception of 4/30 (13%), namely Fetakgomo (59%), Ephraim Mogale; (95%), Ba-Phalaborwa (84%) and Blouberg (91%).
- The provincial expenditure is 99%.

GOOD GOVERNANCE AND PUBLIC PARTICIPATION

- 512 wards committees were established. All municipalities have budgeted for the activities of ward committees as compared to the previous financial year where only eighteen were able to finance the activities of ward committees.
- All municipalities have been allocated Community Development Workers by the Office of the Premier. The challenges were the varying level of capacity of the CDW. Therefore the capacity building programme for ward committees became a critical component of achieving substantive public participation.
- The functionality of IGR structures varies from one district to the other; however only two districts (Mopani and Capricorn) have functional IGR structures.
- All districts have developed the Disaster Management Framework.
