

#### **GENERAL NOTICE 217 OF 2013**

#### **ELECTORAL COMMISSION**

#### **ELECTION TIMETABLE**

The Electoral Commission hereby gives notice that it has in terms of section 11 of the Local Government: Municipal Electoral Act, 2000, compiled the election timetable set out below to apply to the municipal by-elections to be held on 03 July 2013 in respect of Ward 4 of the Mookgophong [LIM364] Municipality and Ward 4 of the Mutale [LIM342] Municipality as proclaimed by Provincial Notice numbers 208 and 209 of 2013 as published in the Provincial Gazette No 2202 of the Limpopo Province respectively, dated 31 May 2013. A reference to "section" in this election timetable is a reference to that section in the Local Government: Municipal Electoral Act, 2000 (Act No. 27 of 2000).

## Cut-off time for act to be performed

An act required in terms of this Act to be performed by not later than a date in the election timetable must be performed before 17:00 on that date, unless otherwise specified.

#### Certification of the voters' roll

By 6 June 2013 the chief electoral officer must certify the segments of the voters' roll for the voting districts to be used in the by-elections in terms of section 6(2)(a).

#### Notice that lists of addresses of voting stations are available for inspection

By 6 June 2013 the chief electoral officer must give notice that copies of a list of voting stations and their addresses will be available for inspection at the office of the Commission's local representative in terms of section 19(5).

#### Notice of route of mobile voting stations

If the Commission decides to use mobile voting stations in the byelections, the Commission must by 6 June 2013 give notice of the route, including the locations and estimated times of stopping of each mobile voting station in terms of section 22(1).

#### Cut-off date for nomination of ward candidates to contest an election

By no later than 11 June 2013 at 17h00, the nomination of a person to contest the by-election in a municipality as a ward candidate must be submitted to the Commission's local representative on a prescribed form and in the prescribed manner in terms of section 17(1).

## Cut-off date for compilation and certification of ward candidate lists

By 19 June 2013 the Commission must compile for each ward a list of ward candidates, certify those lists for that by-election, and keep copies of the lists available at the office of the Commission's local representative in terms of section 18 (1).

## **Cut-off date for issuing certificates**

By 19 June 2013 the Commission must issue to each ward candidate contesting the by-election, a prescribed certificate in terms of section 18(1)(d).

## Application for special vote

- 8 10(1) By no later than 20 July 2013 a voter may apply in terms of Regulation 28B (1) to cast special vote within the voting district where she or he is registered. [Applications for special votes will only be received from 13 June 2013]
  - (2) On 2 July 2013 voters who had successfully applied to cast their special votes at the voting station, may visit the voting station between 08h00 and 17h00 to cast their special votes.
  - (3) On 2 July 2013 voting officers must visit voters who had successfully applied to cast their special votes at their places of residence, to afford them the opportunity to cast their votes there.
