

Notice is hereby given in terms of section 49 (1) (a) (i) read together with section 78 (2) of the Local Government: Municipal Property Rates Act, 2004 (Act No. 6 of 2004), hereinafter referred to as the "Act", that the supplementary valuation roll for the financial years 2012 / 2016 is open for public inspection at Reception Desk, Civic Centre, Irwin street, Musina, from 27 January 2014 to 26 February 2014.
