

PUBLIC NOTICE CALLING FOR INSPECTION OF THE SUPPLEMENTARY VALUATION ROLL AND LODGING OF OBJECTIONS.

Notice is hereby given in terms of section 49(1) (a)(i) read together with section 78(2) of the Local Government: Municipal Property Rates Act, 2004 (Act 6 of 2004) and herein after referred to as the "Act", that the Supplementary Valuation Roll for the financial year 2013/2014 is open for public inspection at all the offices of the Molemole Local Municipality from 23 May 2014 to 01 July 2014.

An invitation is hereby made in terms of section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires should lodge an objection with the Municipal Manager in the prescribed manner in respect of any matter reflected in, or omitted from, the General Valuation Roll within the abovementioned period.
