

CALL FOR NOMINATIONS FOR A PROFESSIONAL VALUER AND ALTERNATES

MEMBERS OF THE VALUATION APPEAL BOARD IN TERMS OF SECTION 64 OF THE

LOCAL GOVERNMENT: MUNICIPAL PROPERTY RATES ACT, 2004 (ACT 6 OF 2004)

I, Makoma Makhupetje, Member of the Executive Council responsible for Co-Operative Governance, Human Settlements and Traditional Affairs hereby call for nominations for a professional valuer in compliance with section 58(1)(b) and 63 and alternate members of the Valuation Appeal Board in terms of section 64 of the Local Government: Municipal Property Rates Act, 2004 (Act 6 of 2004).

A person to be appointed in terms of in compliance with section 58(1)(b) and 63 must be a professional valuer registered in terms of the Property Valuers Profession Act, 2000 (Act 47 of 2000).

Section 64 of the act provides that:

- The MEC for local government may appoint alternate members of an appeal board.
- (2) The person appointed as the alternate for the chairperson of an appeal board must be a person with legal qualifications and sufficient experience in the administration of justice.
- (3) An alternate acts as a member when:
 - (a) a member is absent, has recused himself or herself or is suspended; or
 - (b) the filling of a vacancy on the board is pending.

Functions of the board are:

- (a) to hear and decide appeals against the decision of a municipal valuer concerning objections to
 matters reflected in, or omitted from, the valuation roll of a municipality in the area for which it
 was established in terms of section 56; and
- (b) to review decisions of a municipal valuer submitted to it in terms of section 52. NB: Term of office for these nominations is up to the 30th September 2015.
