

#### **PROVINCIAL NOTICE 103 OF 2016**

NOTICE OF LIMPOPO PROVINCIAL GOVERNMENT DEPARTMENT OF TRANSPORT

NOTICE IN TERMS OF SECTION 23 AND 24 OF THE NATIONAL LAND TRANSPORT ACT 2009 (ACT NO 5 OF 2009): DISESTABLISHMENT OF THE CURRENT PROVINCIAL REGULATORY ENTITY AND ESTABLISHMENT OF A PROVINCIAL REGULATORY ENTITY.

- By virtue of the powers vested in me in terms of sections 23 and 24 of the National Land Transport Act (Act 5 of 2009) I, Mapula Mokaba-Phukwana, Member of the Executive Council responsible for Transport, Safety, Security and Liaison hereby, with effect from 01 November 2016:
  - a) disestablish and dissolve the said Current Limpopo Provincial Regulatory Entity.
  - b) transfer the functions of the Current Limpopo Provincial Regulatory Entity established in terms of sections 23 and 24 of the National Land Transport Act (Act 5 of 2009) to the Provincial Regulatory Entity; and
  - c) establish the Limpopo Provincial Regulatory Entity;
- Any application to the said Current Limpopo Provincial Regulatory Entity relating to the granting, amendment, renewal or transfer of an operating licence which has not been disposed on or before 01 November 2016, is deemed to be an application to the said Limpopo Provincial Regulatory Entity relating to the appropriate operating licence.

All assets, rights, liabilities and obligations of the said Current Limpopo Provincial Regulatory Entity are transferred to and vest in the said Limpopo Provincial Regulatory Entity, which is for all purposes the successor-in-law of the disestablished Current Limpopo Provincial Regulatory Entity.
