

ROLL AND LODGING OF OBJECTIONS FOR 2016/2017 FINANCIAL YEAR**

This notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government Municipal Property Rates Act 2004 (Act No.6 of 2004), hereinafter referred to as the "Act", that the supplementary valuation roll for the 2016/2017 financial year will be open for public inspection from 15 November 2016 at the offices of Fetakgomo-Greater Tubatse Municipality in Burgersfort, Ga-Mapodile, Praktiseer, Ohrigstad and Apel regional office.

An invitation is hereby extended in terms of Section 49(1)(a)(ii) of the Act that any owner of the property or other person who desires, should lodge an objection with the respective Municipal Manager in respect of any matter reflected in, or omitted from the Supplementary Valuation Roll.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such.

The closing date for objections is 15 December 2016.

The form for lodging an objection is obtainable at the stated Municipal offices.

The completed forms must be returned within the time period specified above to the above mentioned Municipal offices.
