**PUBLIC NOTICE: CALLING FOR INSPECTION OF THE GENERAL VALUATION
ROLL AND LODGING OF OBJECTIONS.**

Notice is hereby given in terms of Section 49(1)(a)(i) read together with Section 50 of the Local Government: Municipal Property Rates Act, 2004 (Act 6 of 2004) and herein after referred to as the "Act", that the General Valuation Roll for 2017 to 2022 financial year is open for public inspection at all the Municipal offices.

An invitation is hereby made in terms of Section 49(1)(a)(i) of the Act that any owner of the property or other interested person who resides within the jurisdiction of the municipality so desired should lodge an objection with the Municipal Manager in the prescribed manner in respect of any matter reflected in, or omitted from the valuation Roll before the 31st January 2017.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act, an objection must be in relation to a specific individual property and not against the valuation roll as such.
