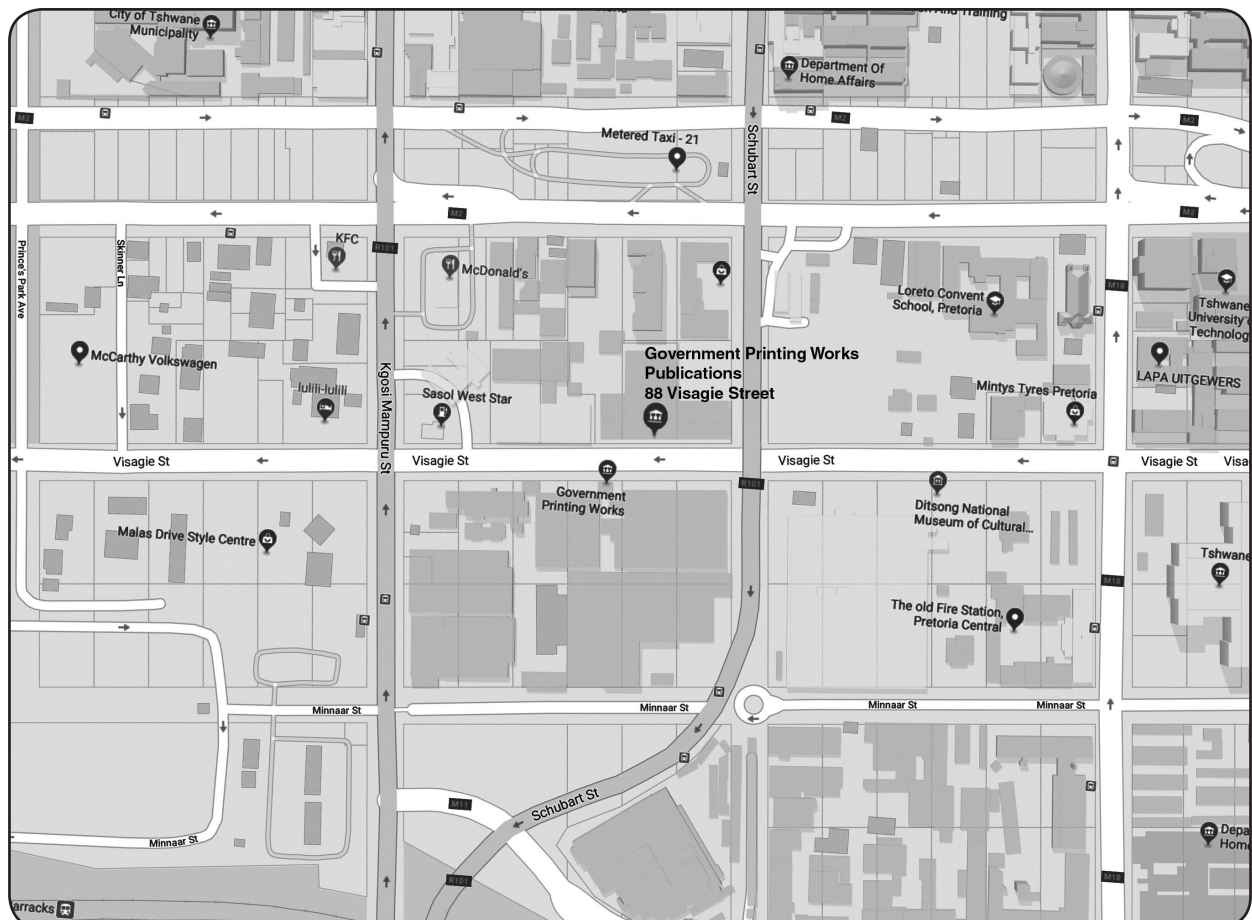

I, Mr R.B Makamu, Member of the Executive Council responsible for Co-Operative Governance, Human Settlements and Traditional Affairs in Limpopo Province, by powers vested in me, hereby call for nominations and applications of members of the Limpopo Valuation Appeal Board to be established in terms of section 56 of the Local Government: Property Rates Act, 2004 (Act 6 of 2004).

Nominated persons and applicants must be people with legal qualifications, professional valuers registered in terms of the Property Valuers Profession Act, 2000 (Act 47 of 2000) and people with sufficient knowledge of or experience in the valuation of property.

Functions of the valuation appeal board are to hear and decide appeals against the decisions of a municipal valuer concerning objections to matters reflected in or omitted from, the valuation roll of a municipality and to review decisions of a municipal valuer. Term of office of the board is four (4) years.

Nominations and applications must be supported by a comprehensive curriculum vitae, certified copies of qualifications and any other supporting documents.
