Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government: Municipal Property Rates Act, 2004 (Act No. 6 of 2004) hereinafter referred to as the "Act" that the valuation roll for the financial year 1<sup>st</sup> July 2009 to 30<sup>th</sup> June 2013 is open for inspection at the municipal office in 24 Kwaggafontein, across Police Station from 26 February 2009 until 30 April 2009 during office hours: Monday to Friday from 08:00 until 16:15.

An invitation is hereby made in terms of Section 49(1)(a)(ii) of the "Act" that any owner of property or other person who so desire should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from the valuation roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the "Act" that an objection must be in relation to a specific individual property and not against the valuation roll as such.
