#### CALL FOR NOMINATIONS - BOARD MEMBERS FOR MPUMALANGA TOURISM AND PARKS AGENCY

The Member of the Executive Council (MEC) responsible for the Department of Economic Development, Environment and Tourism is hereby calling for the nomination of individuals to serve as members of the Board for Mpumalanga Tourism and Parks Agency in terms of Section 7(2) of the Mpumalanga Tourism and Parks Agency Act, 2005 (Act No.5 of 2005)

In terms of the Mpumalanga Tourism and Parks Agency Act, 2005 (Act No. 5 of 2005) a new Board consisting of not fewer than 9 and not more than eleven Board Members eligible to vote at Board meetings must be appointed by the responsible Member of the Executive Council.

Nominees proposed shall be fit and proper persons, South African Citizens, broadly representative of the population of the Province and have sufficient knowledge of, or experience in tourism or conservation of natural resources.

Section 8 of the Mpumalanga Tourism and Parks Agency Act, 2005 list grounds on which a person is disqualified from being appointed or remaining a Member of the Board and they are :

- becoming a member of the National Assembly or NCOP, any provincial legislature, municipality or being in the full-time employ of an organ of State other than the Agency;
- becoming subject to a final sequestration order under the Insolvency Act, 1936;
- being declared by a competent court to be of unsound mind or mentally disordered or defective;
- being convicted of any offence under this Act, or any other offence involving dishonesty for which he or she was sentenced to a minimum prison sentence of three months without the option of a fine.


