### SCHEDULE

- 1. The institutions or organizations hereunder are invited to nominate members of the PEB:
  - One (1) representative from the association of school principals in the Province;
  - One (1) representative from the FET College Principals;
  - One (1) representative from the ABET sector in the Province;
  - One (1) representative from each of the recognized School Governing Body associations in the province;
  - One (1) representative from each of the recognized teacher unions;
  - One representative from each of the higher education institutions in the province;
  - One (1) representative from Umalusi;
  - One (1) representative from independent schools;
  - One (1) representative from the distance education colleges; and
  - Two (2) representatives from the Provincial Education Department.

The MEC for Education may appoint additional members to the Board as he or she deems fit.

2. Functions of the Provincial Examination Board:

In order to ensure that the credibility and integrity of the Public examination system is enhanced within the province, the PEB will perform the following functions:

- Advice the MEC on policy and related matters on examinations and assessment, as it relates to the province.
- Address all matters of public concern relating to examinations conducted for schools, Adult Education and FET Colleges.
- Advise the MEC on mechanisms that need to be adopted to improve public confidence in the provincial examination system.
- Deal with all examinations and assessment matters referred to it by the MEC.
- Report to the National Examination Board (NEB) on matters that are of provincial concern relating to the integrity and credibility of the public examinations.

It must be noted that serving as a member of the Provincial Examination Board is a voluntary community service. It is not a work opportunity or necessarily remunerative. Therefore no salaries are paid to PEB members. PEB members who are not employed by government may be paid for legitimate subsistence and travel expenses in accordance with government tariff guidelines.

Representatives nominated must have a demonstrable interest in the improvement of quality and equity in the education system in the province with special reference to examinations.
