

Invitation to submit Applications in terms of the Request for Applications for Limited Pay-out Machines Licences ("RFA")

Target Groups: Prospective Applicants for Site Operator Licences

Prospective Applicants for Independent Site Operator Licences

The Mpumalanga Economic Regulator ("MER") hereby invite applications for site operator and independent site operator licences from 3 June 2022.

The RFA issued on 8 April 2022 describes the process that the MER will follow to consider applications for site operator and independent site operator licences. This invitation is open until such time the Board announces its closure or publishes a revised RFA. The aforementioned RFA was open for clarification questions and responses to the questions are enclosed in the RFA (from page 28 onwards) and can be downloaded from the MER's website: www.mer.org.za.

In as far as the allocation of limited payout machines for independent site operator licences (in terms of section 2.1.1 of the RFA) is concerned, the following should be noted:

- 1. Applications for independent site operator licences wishing to participate in the 240 limited payout machines allocation must be submitted on or before 31 August 2022.
- 2. The following independent site operator licences were issued:
 - Ehlanzeni District: One (1) licence with 40 limited payout machines;
 - Gert Sibande District: One (1) licence with 40 limited payout machines; and
 - Nkangala District: Two (2) licences with 40 limited payout machines each.
- 3. The allocation split of limited payout machines between site operators and independent site operators will lapse after 31 August 2022.

Interested parties must also note that delays may occur, if significantly more applications are received than originally anticipated.
