

OPERATOR LICENCE TO OTHER PREMISES Notice is hereby given that Arnostyle (Pty) Ltd, trading as Great Bingo Mbombela ("Great Bingo"), the holder of a Bingo Operator licence issued by the Mpumalanga Gambling Board in respect of premises located at 24 Jerepico Street, Mbombela ("the Licence"), and Galaxy Bingo Emalahleni (Pty) Ltd ("GBEM") intend submitting a joint application to the Mpumalanga Economic Regulator ("MER") for the transfer of the Licence from Great Bingo to GBEM.
