LOCAL GOVERNMENT TRANSITION ACT SECOND AMENDMENT ACT, 1996 (ACT No. 97 OF 1996)

By virtue of the power vested in me by Section 10N (4) (a) of the Local Government Transition Act Second Amendment Act, 1996 (Act No. 97 of 1996), I hereby repeal Proclamation No. 54 of 1994 as promulgated in The Province of the Cape of Good Hope *Official Gazette* dated 6 May 1994, and I hereby make the enactment contained in the Schedule hereto.

This Proclamation comes into operation with effect from the date hereof.

SCHEDULE

With effect from the date that this Proclamation comes into effect:

A local government body as defined in section 1 of the Local Government Transition Act, 1993 (Act 209 of 1993) as read with section 13 (3) of that Act, or as the case may be, a transitional council as so defined, and the employees of such local government body, may, notwithstanding any other law to the contrary, by means of collective bargaining in terms of the Labour Relations Act, 1995, resolve to be associated with any pension fund or funds, as defined by section 1 of The Income Tax Act, 1962 (Act 58 of 1962), as amended, subject to:

(i) An association with only such pension fund or funds as determined by means of collective bargaining, in terms of the Labour Relations Act, 1995, at divisional level of the South African Local Government Bargaining Council: Provided that all such funds will provide for a compulsory transfer of vested rights between such funds where an employee has carried out his rights under this Proclamation; and

(ii) the local government body shall contribute in respect of all eligible employees in the service of such local government body, the relevant employer's contribution to any pension fund; and

(iii) every pension fund contemplated herein shall be registered in terms of The Pensions Fund Act, 1956 and shall be subject to all the provisions of the said Act.





