



NOTICE FOR GUIDELINES FOR THE PREPARATION OF A BUDGET OF A PUBLIC SCHOOL

I, Tina Monica Joemat-Pettersson, Member of the Executive Council responsible for Education hereby give notice in terms of section 38 (1) of the South African School Act (Act No. 84 of 1996), guidelines for the preparation of a budget of Public Schools as set out in the Schedule.

GUIDELINES FOR THE PREPARATION OF A BUDGET FOR A PUBLIC SCHOOL

The Member of the Executive Council for Education has in terms of section 38 (1) of the South African-Schools Act (Act No. 84 of 1996), made these guidelines for the preparation of a budget for a public school.

1. OBJECTIVE

- 1.1 The objective of a School Budget is for the School Governing Body to give the parents all necessary information about the School's—
 - (a) income, from the state and other sources;
 - (b) educational needs; and
 - (c) expenditure.

2. RESPONSIBILITY

- 2.1 The responsibility of preparing a School budget is vested in the School Governing Body of a public school.
- 2.2 The Principal of a public school and any official of the Education Department shall provide all reasonable assistance to the School Governing Body in terms of its responsibility in subsection 2.1 above.

3. USE OF INFORMATION

- 3.1 In preparation of the school budget, the School Governing Body of a Public School shall use all the information as provided by the Education Department on or before the 30 September of the year preceding that for which the school budget is being prepared.
- 3.2 Such information, as envisaged in subsection 3.1, may include—
 - (a) a record of the Schools expenditure for a period as determined by the Education Department;
 - (b) the financial allocation to the school from the Department of certain items as specified by the Department and for the school financial year which the Schools budget is being prepared; and
 - (c) the allocation of functions in terms of section 21 of the South African Schools Act (Act No. 84 of 1996), to the school.

4. SCHOOL FINANCIAL YEAR

- 4.1 The financial year of a public school shall be from 01 January to 31 December of a particular calendar month period.
- 4.2 The School budget shall be prepared for this period.

5. BUDGET FORMAT

- 5.1 The School budget shall be prepared in the format as in Annexure A, B and C.
- 5.2 The Department may request a School budget in a different format from the one envisaged in subsection 5.1.
- 5.3 A School Governing Body may use a different format from the one envisaged in subsection 5.1 only with the written approval of the Provincial Head of Department of Education.

6. FUNDING ALLOCATIONS

- 6.1 Funds allocated to the school for the purposes of learning materials, recurrent expenditure and maintenance of school property, either as a lump sum cash transfer or as a paper budget, must be budgeted for against the items for which they have been allocated.
- 6.2 Funds allocated for the purpose of learning materials as referred to in section 6.1 above must be utilised only for that purpose.

6.3 Funds allocated for the purposes of recurrent expenditure and maintenance of school property as referred to in subsection 6.1 above must first be utilised for such purposes before they are utilised for any other educational expenditure or expense items. The approval of the member of the Executive Council responsible for Education must first be sought and received before the funds are utilised for other educational expenditure or expense items.

7. ADOPTION/RATIFICATION OF THE BUDGET

7.1 The treasurer of the School Governing Body shall submit the School budget to a properly Constituted meeting of the School Governing Body for adoption/ratification/approval before the budget is submitted to a meeting of parents as envisaged in subsection 8.1.

7.2 Such adoption/ratification/approval as envisaged in subsection 7.1 shall be recorded in the minutes of the meeting.

8. PRESENTATION TO PARENTS

8.1 After adoption/ratification/approval of the School budget as envisaged in subsection 7.1 The School Governing Body shall convene a meeting of parents by giving 30 days notice and at which meeting the School budget shall be presented by the treasurer of the School Governing Body or any other duly mandated member of the School Governing Body.

8.2 The majority of parents present at the meeting, envisaged in Subsection 8.1 and voting shall adopt the school budget by voting.

8.3 The majority of parents at this meeting and voting shall after adoption of the School budget

(a) decide on the payment and amount of school fees

(b) decide on the exemption of parents to pay schoolfees.

9. EVALUATION OF THE BUDGET

9.1 The School Governing Body must submit the School budget to the Regional Office of the Department within seven (7) days of the meeting referred to in subsection 8.1 for evaluation.

9.2 Evaluation of the School budget shall be based on

(a) fulfilment of the provisions of these guidelines,

(b) the educational needs of the school and

(c) the objectives, priorities and policies of the Department

9.3 After evaluation of the School budget, the Department may ask a School Governing Body to review its budget and to bring it in line with the requirements of the Department.
