

#### LOCAL GOVERNMENT: MUNICIPAL STRUCTURES AMENDMENT ACT, 2000

Under section 18 of the Local Government: Municipal Structures Amendment Act, 2000 (Act No. 33 of 2000), and on the recommendations of the Municipal Demarcation Board, I, O. P. Dikgetsi, hereby authorise the local and district municipalities mentioned in the first and the second column of the Annexure to the Schedule hereto, to perform the functions or exercise the powers of the nature described in the third column of the corresponding row of the said Annexure.

#### SCHEDULE

#### **Definitions**

- 1. In this Schedule, unless the context indicates otherwise, or unless redefined herein, a word or expression to which a meaning has been assigned in the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), chapter two of the Amendment Act and the section 12 notice has the same meaning and—
  - "Amendment Act" means the Local Government Municipal Structures Amendment Act (Act No. 33 of 2000);
  - "district municipalities" means the Category C municipalities established in terms of section 12 notices, and "district municipality" has a corresponding meaning;
  - "local municipality" means the Category B municipality established in terms of section 12 notice, and "local municipality" has a corresponding meaning;
  - "section 12 notices" means the notices issued under section 12 of the Structures Act in terms of which district municipalities and local municipalities specified in the notices, for which elections were held on the 5 December 2000, were established, and "section 12 notice" has a corresponding meaning; and
  - "Structures Act" means the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998);
  - "Section 84" means section 84 of the Local Government: Municipal Structures Act, 1998;
  - "Schedule 4" means Schedule 4 to the Constitution, 1996; and
  - "Schedule 5" means Schedule 5 to the Constitution, 1996.

#### **Authorisation**

- 2. (1) In terms of section 18(1)(a) of the Amendment Act, the local municipalities mentioned in the first and second column of the Annexure to this Schedule are authorised to perform the functions and exercise the power of the nature described in the third column of the corresponding row of the said Annexure in their area.
- (2) In terms of section 18(1)(b) of the Amendment Act, the district municipalities mentioned in the first and the second column of the Annexure to this Schedule are authorised to perform the functions or exercise the powers of the nature described in the third column of the corresponding row of the said Annexure in their area.
- (3) (a) Any local municipality which is authorised in terms of subparagraph (1) to perform any function or exercise any power, must assume full responsibility and accountability for those functions or powers and their effective and efficient performance or exercise.
- (b) Any district municipality which is authorised in terms of subparagraph (2) to perform any function or exercise any power, must assume full responsibility and accountability for those functions or powers and their effective and efficient performance or exercise.

### Legal, practical and other consequences of the authorisation

- The provisions regarding—
  - (a) the transfer of assets, rights, liabilities and obligations;
  - (b) the transfer of staff:
  - (c) administrative units; and
  - (d) the continued application of by-laws and resolutions,

# set out in section 12 notices establishing the municipalities, apply with the necessary changes required by the context, to the performance of a function or the exercise of a power by a municipality that is authorised to perform such function or exercise such power in accordance with this Notice.
