HUNTING SEASONS, DAILY BAG LIMITS AND HUNTING BY PROHIBITED HUNTING METHODS

Under the powers vested in me by sections 78 and 79 of the Nature and Environmental Conservation Ordinance, 1974 (Ordinance No. 19 of 1974), I hereby determine for the year 2009

- the species of protected wild animals, and other wild animals whereon the Proclamation is applicable as listed in columns one and two of **Schedule 1**;
- the hunting seasons, areas and the daily bag limits as set out in the third, fourth and fifth columns, respectively, of **Schedule 1** hereto,
- and the extent of the suspension of sections 29 and 33(1) in terms of section 79(b), as specified in **Schedule 2** and column six of **Schedule 1**.

EXPLANATORY ADDENDUM (SCHEDULE 2)

Column 6 of the Hunting Proclamation indicates the extent to which sections 29 (prohibited hunting methods) and 33(1) (use of motor vehicle) in terms of section 79(b), is suspended. When the relevant paragraph of sections 29 and 33(1) is suspended in the Hunting Proclamation in respect of a specified species, it means that specific prohibited hunting methods may be used to hunt that species. Warthog, for example, may be hunted with a light (b) and during the night (e). A short explanation of each paragraph mentioned in the Hunting Proclamation is furnished hereunder:

Section 29 (Prohibited hunting methods) in terms of section 79(b) of the Nature and Environmental Conservation Ordinance, 1974 (Ordinance No. 19 of 1974).

- Paragraph (b): hunting with the aid of artificial light;
- Paragraph (c): on or from a public road;
- Paragraph (d): hunting by means of any trap/cage trap;
- Paragraph (e): hunting during the period one hour after sunset on any day and one hour before sunrise on the following day;
- Paragraph (g): hunting by means of a fire-arm which discharges a rim-fire cartridge of a calibre less than 5,6 mm;
- Paragraph (j): hunting by means of a set gun or any similar contrivance;
- Paragraph (l): hunting by the use of a dog.

Section 33 (1): Prohibition on use of motor vehicles or aircraft for the purpose of hunting wild animals or of filming or photographing a hunt, etc, of such animals, in terms of section 79(b).

Subject to the provisions of subsection (2), no person shall without a permit use any motor vehicle or aircraft to hunt any wild animal or to hunt, disturb, drive or stampede any wild animal or animals for the purpose of filming or photographing such hunt, disturbance, drive or stampede or for any other purpose whatsoever.

VERDUIDELIKENDE ADDENDUM (BYLAE 2)

In Kolom 6 van die Jagproklamasie word die mate waarin artikels 29 (verbode jagmetodes) en 33(1) (gebruik van motorvoertuig) in terme van artikel 79(b), opgehef word, aangedui. Wanneer die betrokke paragrawe van artikels 29 en 33(1) in die Jagproklamasie ten opsigte van 'n bepaalde spesie opgehef word, beteken dit dat daardie verbode jagmetodes aangewend kan word om die spesie te jag. Soos byvoorbeeld, mag vlakvarke met 'n lig (b) en gedurende die nag (e), gejag word. 'n Kort uiteensetting van elke paragraaf wat in die jagproklamasie genoem word, word hieronder verskaf:

Artikel 29: Verbode Jagmetodes in terme van artikel 79(b) van die Ordonnansie op Natuur- en Omgewingsbewaring, 1974 (Ordonnansie No. 19 van 1974).

- Paragraaf (b): Jag met behulp van 'n kunsmatige lig;
- Paragraaf (c): op of vanaf 'n openbare pad;
- Paragraaf (d): jag deur middel van 'n strik/vanghok;
- Paragraaf (e): jag gedurende die tydperk een uur na sononder op enige dag en een uur voor sonop die volgende dag;
- Paragraaf (g): jag deur middel van 'n vuurwapen wat 'n patroon met randontstekking en 'n kaliber van minder as 5,6 mm afskiet;
- Paragraaf (j): jag deur middel van 'n gestelde geweer of enige dergelike apparaat;
- Paragraaf (l): jag deur gebruik te maak van 'n hond.

Artikel 33(1): Verbod op gebruik van motorvoertuie of lugvaartuie met die doel om wilde diere te jag of om die jag ens. op sodanige diere te verfilm of te fotografeer, in terme van artikel 79(b).

Behoudens die bepalings van subartikel (2) mag niemand sonder 'n permit enige motorvoertuig of lugvaartuig gebruik om enige wilde dier te jag of om enige wilde dier of diere te jag, te verstoor, aan te dryf of op loop te jag met die doel om sodanige jag, verstoring, aandrywing of vlug te verfilm of te fotografeer of vir enige ander doel wat ook al nie.

Schedule

Definitions

1. In this Schedule, unless the context indicates otherwise, or unless redefined herein, a word or expression to which a meaning has been assigned in the Local Government: Municipal Structures Act, Chapter 2 of the Local Government: Municipal Structures Amendment Act and section 12 notice has the same meaning and -

"Amendment Act" means the Local Government: Municipal Structures Amendment Act, 2000 (Act No. 33 of 2000);

"district municipalities" means the Category C municipalities established in terms of section 12 notices, and "district municipality" has a corresponding meaning;

"local municipalities" means the Category B municipalities established in terms of the section 12 notices, and "local municipalities" has a corresponding meaning;

"Structures Act" means the Local Government: Structures Act, 1998 (Act No. 117 of 1998);

"section 12 notice" means the notices issued under section 12 of the Local Government: Structures Act in terms of which the district and local municipalities specified in the notices, for which elections were held on 5 December 2005 and 1 March 2006 were established, and section 12 notice has a corresponding meaning; and

"ceding municipality" means the district or local municipality which loses a function or power, such function or power being allocated to another municipality in terms of Annexure "A" of this Schedule;

"effective date" means **01 July 2009**.

2. Adjustment of the division of functions and powers between district and local municipalities by way of allocation.

In terms of section 85 of the Act and with effect from **01 July 2009**, the division of functions and powers between the district and local municipalities is adjusted by way of allocations in accordance with the Annexure hereto, and for purposes of the said Annexure, "function" includes "power".

3. Legal, practical and other consequences of the adjustments.

The provisions regarding –

- (a) The transfer of staff;
- (b) The transfer of assets, liabilities, rights and obligations and administrative units and other records;
- (c) The continued application of any by-laws, regulation and resolutions in the area of the municipalities concerned and the extent of such application,

Set out in the section 12 notices establishing the municipalities, continue to apply with the necessary changes required by the context to the performance of a function or the exercise of a power where such function or power is allocated to the district municipality or a local municipality in accordance with this Notice.
