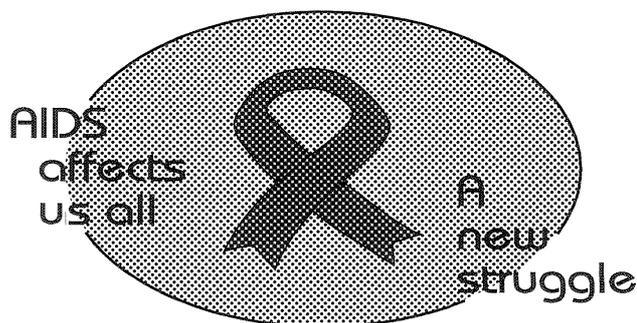

GENERAL NOTICE IN TERMS OF SECTION 6 (1) OF THE LAND TITLES ADJUSTMENT ACT, 1993 (ACT NO 111 OF 1993)

Notice is hereby given in terms of section 6 (1) of the Land Titles Adjustment Act (ACT NO 111 of 1993); Claim [s] for the titles adjustment has been lodged with the North West Provincial Department of Rural Development and Land Reform in respect of **Wilgespruit 2 JQ in the Moses Kotane Local Municipality, Bojanala District on North West Province [Designated Land]** and a Commissioner [Mr Ramatobane Amon Maodi] has been appointed in terms of the Act.

Any person who claims to have acquired a right through hereditary or otherwise to be registered as the owner in respect of such designated land and who is not so registered is called upon to submit to the Commissioner, an application for the allocation and transfer to him / her in terms of this Act in respect of which he / she claims such right, within a period of two [2] months from date of first publication of this notice on 26 August 2013.
