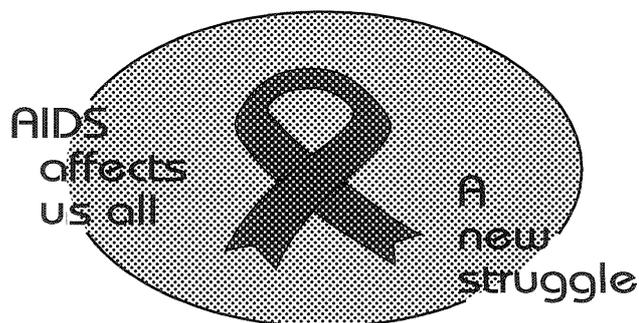



Notice is hereby given in terms of section 49(1) (a)(i) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004), hereinafter referred to as the "Act", that the Valuation Roll for the financial years 1 July 2014 to 30 June 2018 is open for public inspection at Rustenburg Local Municipality from 21 February 2014 to 31 March 2014.
