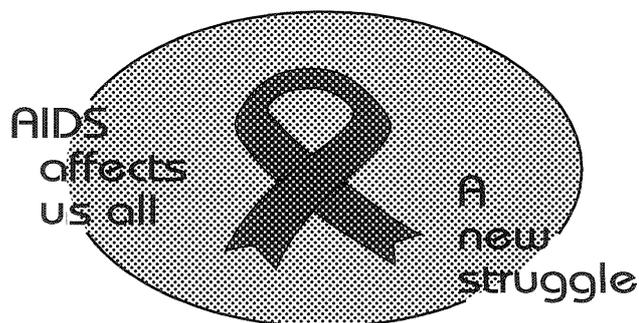

& LIAISON****Notice in terms of Section 3 of the North West Road Traffic Act, Act No 11 of 1997.**

BE PLEASED to take notice that the Member of the Executive Council responsible for Traffic in the North West, has granted approval in terms of Section 3 (1)(c) (ii) of the North West Road Traffic Act, Act 11 of 1997, for the traffic officers of the Local Municipal Councils listed in the Schedule, to function outside such Municipality areas to include Provincial roads situated or traversed by such Municipal areas, only up to the area of jurisdiction of the Provincial Traffic Office in that area.

Provided that the provisions of Sections 46 and 47 respectively shall with regard to apportionment of fines and fees remain the same.

Provided further that the foregoing authority be conditional upon the Member of the Executive Council responsible for Traffic having the right to amend or withdraw such authority or any part thereof at anytime.
