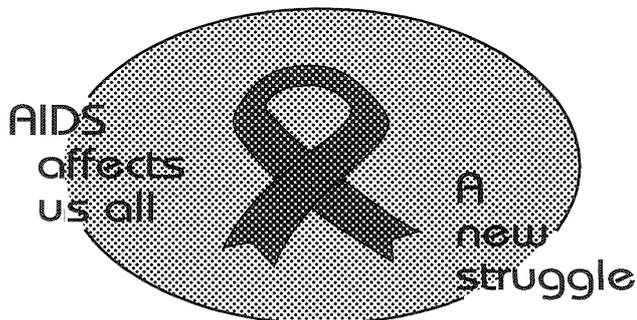

### NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT, 2001 (ACT NO.2 OF 2001) AS AMENDED

#### APPLICATIONS FOR SITE OPERATOR LICENCES

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended, that the North West Gambling Board ("the Board") received applications for Site Operator Licences, as listed below.

A Site Operator licence authorises a licensee to place and operate approved Limited Payout Machines in or on premises or parts of such premises, as licensed by the Board.
