CALL FOR NOMINATIONS OF MEMBERS OF THE CONSUMER COURT IN TERMS OF SECTION 11(3) OF THE CONSUMER AFFAIRS (HARMFUL BUSINESS PRACTICES) ACT NO. 4 OF 1996 AS AMENDED

I, Wendy Nelson, Member of Executive Council responsible for the Department of Economy and Enterprise Development, hereby make a call for nominations of persons, within (30) days from the date of publication of this notice, to be appointed to the Provincial Consumer Court in terms of the Consumer Affairs (Harmful Business Practices), Act No. 4 of 1996 as amended.

The court shall consist of (3) members, one of whom shall be designated as the Chairperson. The Chairperson must be a retired Judge of the High Court; or an Attorney, Advocate, retired Magistrate or law Lecturer at a University, with not less than (10) years cumulative experience in one or more of such capacities. The other two additional members, of whom, shall be appointed on the ground of having knowledge of or experience in economics industry or commerce.

It should be noted that in terms of section 12(1) of the Act, No person shall be appointed or remain a member or alternate member of a court if such a person is:-

- (a) a Public Servant; or
- (b) a member of Parliament, any Provincial Legislature or Local Authority, or any Council, Commission or House of Traditional Leaders established in terms of the Constitution.
