## PROCLAMATION

**PROCLAMATION IN TERMS OF SECTION 127(2)(e) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996 READ WITH NORTH WEST COMMISSIONS ACT, 1994 (ACT 18 OF 1994): EXTENSION OF THE TERMS OF REFERENCE OF THE BAKGATLA BA KGAFELA, BATLHAKO BA LEEMA, BAPO I & II, BAROLONG BOO RATLOU BOO SEITSHIRO, BAKGATLA BA MMAKAU AND BAHURUTSHE BA GOPANE COMMISSION OF INQUIRIES**

By virtue of the powers vested in me in terms of section 127(2)(e) of the Constitution of the Republic of South Africa, 1996, I Tebogo Job Mokgoro, in my capacity as Premier of the North West Province, hereby extend the term of the Commission of Inquiries established through Proclamation No. 23 of 2018 and published in Government Gazette Notice 7838, dated 26 December 2017 and further determines that the Terms of Reference listed in Proclamation No. 23 of 2018, published under Government Gazette Notice 7840, dated 10 January 2018 shall apply to the Commission of Inquiry in respect of the Bakgatla Ba Kgafela, Batlhako Ba Leema, Bapo I & II and Government Gazette Notice 7883, dated 15 May 2018 shall apply for Barolong Boo Ratlou Boo Seitshiro, Bakgatla Ba Mmakau and Bahurutshe Ba Gopane.

Clause 4(2) of the Regulation of the Provincial Gazette dated 21 September 2016 shall apply in respect of Bakgatla Ba Kgafela, Batlhako Ba Leema and Bapo I & II in respect of report writing.

The extension period shall be from **02 January 2019 – 31 March 2019**,
