

PUBLIC NOTICE CALLING FOR INSPECTION OF GENERAL VALUATION ROLL

The Municipality has undertaken a general valuation and prepared a certified valuation roll of all properties in its jurisdiction in terms of applicable legislation and policies. Notice is hereby issued in terms of Section 49 (1) (a) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004), as amended, hereinafter referred to as the "Act", that the valuation roll for the period 1 July 2019 to 30 June 2024 is open for public inspection at the various Municipal Offices, Thusong Service Centres and Libraries from **15 February 2019 to 31 March 2019.**

The Valuation Roll can be viewed during office hours, from 15 February 2019 to 31 March 2019 at the various Municipal Offices, Thusong Service Centres and Libraries.

An invitation is hereby made in terms of section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires should lodge an objection with the municipal manager in respect of any matter reflected in, or omitted from, the general valuation roll within the abovementioned period.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation rolls as such. The objection form for the lodging of an objection is obtainable at the various Municipal Offices, Thusong Service Centres and Libraries.
