



PROCLAMATION

DETERMINATION IN RESPECT OF THE ESTABLISHMENT OF NEW DEPARTMENTS, THE ABOLITION OF CERTAIN DEPARTMENTS IN TERMS OF SECTION 3A(a)(i) OF THE PUBLIC SERVICE ACT, 1994 (PROCLAMATION 103 OF 1994), ASSIGNMENT OF POWERS AND FUNCTIONS IN TERMS OF SECTION132(2) AND TRANSFER OF FUNCTIONS IN TERMS OF SECTION 137(b), READ WITH SECTION 140(1)(b) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996

Subsequent to the recent 2019 National and Provincial elections, and by virtue of the powers vested in me, I Tebogo Job Mokgoro, in my capacity as Premier of the North West Province, hereby, with effect from 28 May 2019 and in terms of –

- (1) section 3A(a)(i) of the Public Service Act, 1994 (Proclamation 103 of 1994), abolish certain departments established in terms of Proclamation 7326, published on 12 August 2014, to the extent illustrated under column B of the Schedule hereto and establish certain new departments under column B of the said Schedule;
- (2) section 132(2), read with sections 137(b) and 140(1)(b) of the Constitution of the Republic of South Africa, 1996, assign and transfer powers and functions, to the extent illustrated in column C of the Schedule attached hereto;
- (3) section 3A(b) of the Public Service, 1994, make a determination regarding the allocation and abolition of functions of departments, to the extent illustrated in column C of the Schedule attached hereto.
