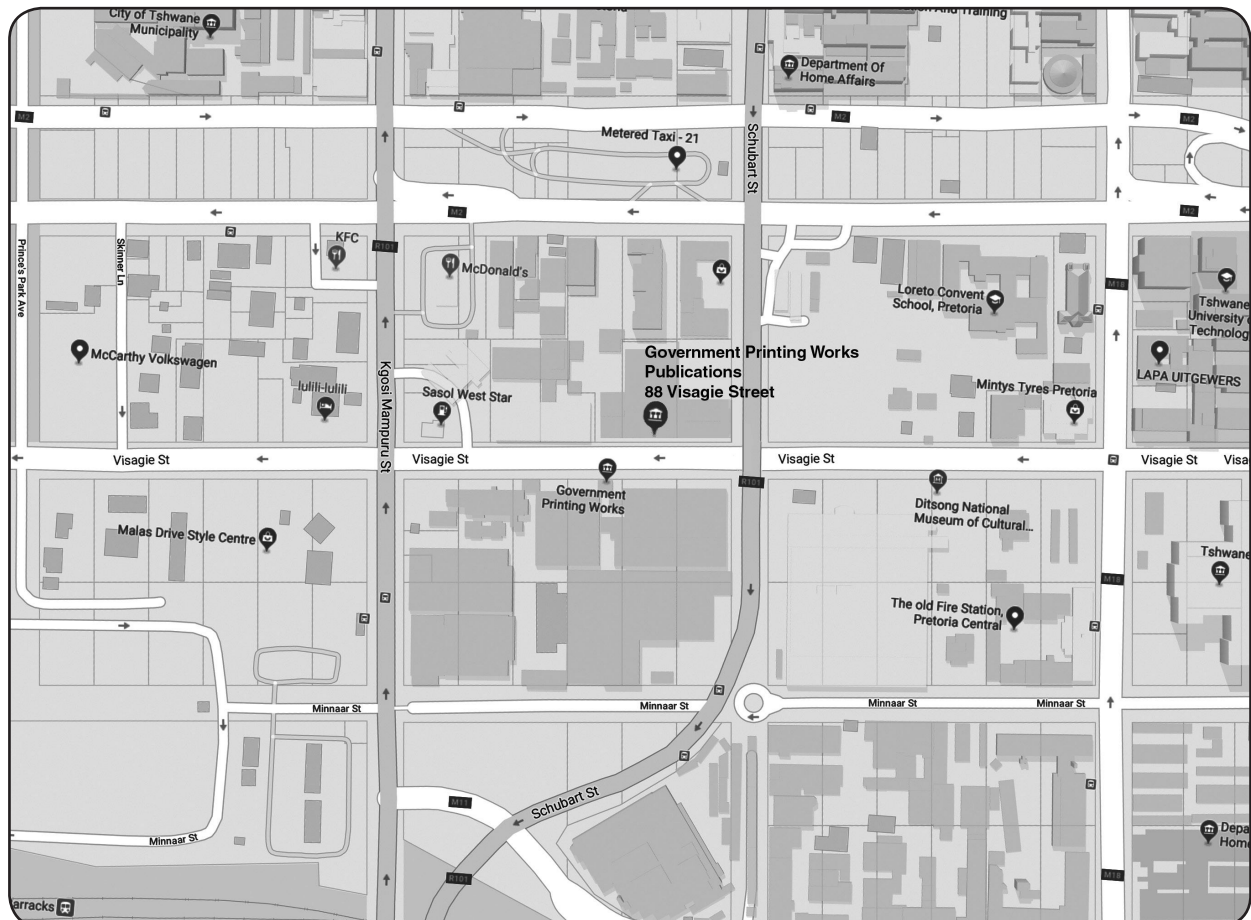

**APPLICATION FOR CONSENT TO PROCURE 40% OF FINANCIAL INTEREST IN SUN CAROUSEL  
(PTY) LTD BY BA MOCHA MAUBANE LEISURE GROUP (PTY) LTD.**

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended, that the North West Gambling Board ("the Board") received an application for consent to procure 40% financial interest by Ba Mocha Maubane Leisure Group (Pty) Ltd in Sun Carousel's casino operations.

In terms of the provisions of section 27A(1) of the North West Gambling Amendment Act, 2005, (Act No. 5 of 2005), "any person who, directly or indirectly procures a controlling interest or a financial interest of five percent or more, or any lesser percentage as may be prescribed, in the business to which a license or a registration in terms of section 60 relates shall, within the prescribed period and in the manner prescribed or determined by the Board, apply for the consent of the Board to hold such interest".

**SUN CAROUSEL (PTY) LTD** is a subsidiary of SISA (Sun International South Africa), licensed to conduct casino operations in the North West Province. Their physical business address is Old Warmbaths Road, Hammanskraal.

**BA MOCHA MAUBANE LEISURE GROUP (PTY) LTD** is a Private Company registered in the Republic of South Africa in terms of the Companies Act, 2008 (Act No. 71 of 2008) with Registration Number **2019/268271/07**.
