

The North West Public Transport Intervention Team is established in terms of Section 10 of the National Land Transport Act No 5 of 2009.

**CALL FOR NOMINATIONS OF MEMBERS TO
SERVE IN THE NORTH WEST PUBLIC
TRANSPORT INTERVENTION TEAM (NWPTIT)**

The Member of the Executive Council for the Department of Community Safety and Transport Management, Hon S.J. Lehari hereby invites nominations by stakeholders, interested groups and suitably qualified individuals to be appointed as members of the North West Public Intervention Team.

The North West Public Intervention Team is established in terms of section 10 of the National Land Transport Act 5 /2009 to attend to the interest of the Public Passenger Transport Industry, particularly the Taxi Sector.

**1. POWERS AND FUNCTIONS OF THE
NORTH WEST INTERVENTION TEAM**

The functions of the team as provided for in Regulation the intervention team may-

- a) Conduct an inspection under this Act or any other applicable law, and
- b) Monitor and enforcement compliance with this Act or any applicable law in consultation with relevant authority but not limited to the South African Police Service, PRE, Traffic Officers where necessary, subject to provisions of any other applicable law –

- i. Question any person in respect of any matter which may be relevant to the investigation,
 - ii. Question any person whom the Intervention Team on reasonable grounds believes may have information relevant to the investigation,
 - iii. Inspect any document that a person is required to maintain in terms of this Act or any other law or that may be relevant to any related investigation,
 - iv. Copy the document referred to in paragraph (iii), or if necessary, remove the document in order to make a copy there from,
 - v. Take photographs or make audio-visual recordings of anything or any person, process, action or condition related to the investigation,
- (c) with the assistance of the South African Police Service member and Traffic Officers seize and remove any object which in its opinion may constitute proof of a contravention of any provision of this Act, and
- d) Do everything that is relevant for conducting the investigation.

Where the Intervention Team seizes anything relating to the investigation it must –

- a) Record it and issue a receipt for it to the owner, or person in control, of the object, and
- b) Secure same pending a decision concerning the finalization of the investigation.

2. COMPOSITION OF THE NORTH WEST INTERVENTION TEAM

The team will be constituted by not less than Nine (9) members and not more than fifteen (15) members appointed by the Member of the Executive Council. The Chairperson and the Deputy of the North West Intervention Team shall be appointed by the Member of the Executive Council amongst other members at their first meeting,

The members of the team must have relevant knowledge, experience or expertise that would enable the team to perform its functions effectively and efficiently,

The members must be appointed by the Member of the Executive Council through formal nomination process.

3. TERMS OF REFERENCE

The terms of reference of the North West Transport Intervention Team shall entail the following-

- a) To investigate any wrong doing/allegation that is leveled

against any person including government officials regarding taxi conflicts in the Province;

- b) To embark upon awareness campaigns for purposes of preventing taxi conflicts;
- c) To handle Taxi conflicts in collaboration with the Department, Taxi Structures and other relevant stakeholders;
- d) To monitor transport situations in the public transport industry;
- e) To identify and monitor all routes that are affected by taxi conflicts in the Province;
- f) To interact with all relevant stakeholders in the industry including Provincial Taxi Councils, Regional Taxi Councils, primary associations and Municipal officials in relation to Taxi conflicts;
- g) To collate all agreements, Memoranda of Understanding, court documents or any correspondence in the routes affected by taxi conflicts in the Province;
- h) To assist in facilitating training for purposes of proactively managing conflicts;

i) To invite inputs from all interested parties whether publicly or openly as it may deem appropriate in the day to day running of its activities;

j) To assist in fostering cooperation within the public transport industry;

k) To examine the above agreements and determine their legality within the context of the laws governing the taxi industry and in collaboration with the Department.

4. REQUIREMENTS

4.1 The person who seeks to serve in the team must have relevant knowledge, experience or expertise in the following or related areas:-

- i. Public Passenger Transport Sector,
- ii. Conflict management and Resolution
- iii. Negotiation and Communication skills
- iv. Report writing skills
- v. Criminal investigation skills, and
- vi. Computer literacy

4.2 Anyone who seeks to serve in the team should not be employed in the Public Service

5. TERM OF OFFICE

The members of the North West Intervention Team shall serve in a part time capacity for a period not exceeding Two (2) years. They are legible for extension of Twelve (12) months at the end of their term of office.

6. REMUNERATION

The members of the team who are not in the employment of the State will be paid such remuneration and allowances as may be determined by the Member of the Executive Council in consultation with the Member of the Executive Council for Finance.

7. NOMINATION PROCEDURE

Nomination must be in writing and submitted to the Head of Office in the office of the Member of the Executive Council for Department of Community Safety and Transport Management, North West Province, before or by 1st June 2021

8. REQUIREMENTS FOR NOMINATIONS

Every nomination must contain –

- i. Full written personal and career particulars of every nominee,
- ii. Full reasons and motivation for the nomination
- iii.

9. ACCEPTANCE BY NOMINEES

- i. A person shall not nominate him/herself to serve in the North West Public Transport Intervention Team
- ii. Written and signed acceptance of the nomination by every nominee.
