

CALL FOR NOMINATIONS TO SERVE ON THE DEDECT EXTERNAL ADVISORY PANEL ON APPEALS IN TERMS OF SECTION 43(5) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT 107 OF 1998 (NEMA)

I, Kenetswe Mosenogi, Member of the Executive Council responsible for the Department of Economic Development, Environment, Conservation and Tourism, hereby make a call for nominations of persons, within 30 days from the date of the publication of this notice, to be appointed as members of the External Advisory Appeals Panel to consider any appeals in terms of the NEMA.

The Panel to be appointed by the MEC will advise on decision making in relation to all Environment and Biodiversity / Conservation Appeals received. The Panel shall consider in an independent and impartial manner appeals lodged in terms of section 43(1) of the NEMA and make written recommendations to the MEC pertaining to administrative decision issued by the Department and include, inter alia, Environmental Authorizations, Compliance Notices, Section 24G Administrative Fines and Section 22A Air Quality Fines.

Requirements

Applicants must have technical expertise and experience in the following fields:

- Environmental Speciality (including but not limited to Environmental Impact Assessment Specialist, Wetland Specialist, Environmental Technologist, Biodiversity and Environmental Scientist);
- Town Planning
- Law (Environmental Law and Administrative Law)
- Biodiversity, and
- Conservation Management

Members appointed to the Panel shall serve for a term not exceeding three (3) years. All nominations must be in writing accompanied by a nominee's formal indication of his or her acceptance of such nomination as well as a comprehensive Curriculum Vitae.
