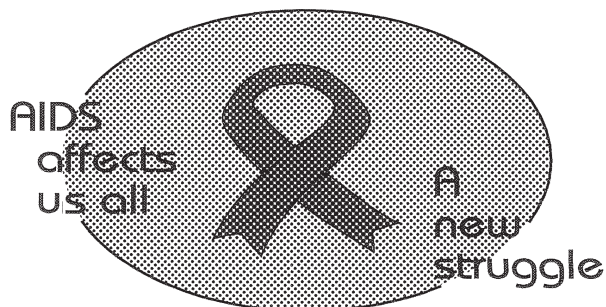

**CALL FOR NOMINATIONS OF CONSUMER AFFAIRS COURT MEMBERS IN TERMS OF SECTION 11(3) OF THE CONSUMER AFFAIRS (UNFAIR BUSINESS PRACTICES) ACT NO. 4 OF 1996, AS AMENDED**

I, Kenetswe Mosenogi, Member of the Executive Council responsible for the Department of Economic Development, Environment, Conservation and Tourism, hereby make a call for nominations of persons, within 30 days from the date of this publication of this notice, to be appointed to the Provincial Consumer Affairs Court in terms of the Consumer Affairs (Unfair Business Practices) Act No. 4 of 1996, as amended.

The Court shall consist of 3 members, one of whom shall be designated as the chairperson. The chairperson who shall be a retired judge of the High Court, or an Attorney, Advocate, retired Magistrate or Law Lecturer at a university, with no less than 10 years cumulative experience in one or more of such capabilities.

Two or four additional members, whom, half shall be appointed on the ground of having experience in economics, industry or commerce.

It should be noted that in terms of section 12(1) of the Act, No person shall be appointed or remain a member or alternate member of the Court if such person is:

- (a) a public servant; or
- (b) a member of Parliament, Provincial Legislature or Local Authority or Council, Commission or House of Traditional Leaders established in terms of the Constitution.

All nominations must be in writing and be accompanied by a nominee's formal indication of his or her acceptance of such nomination, as well as a comprehensive Curriculum Vitae of the nominee
