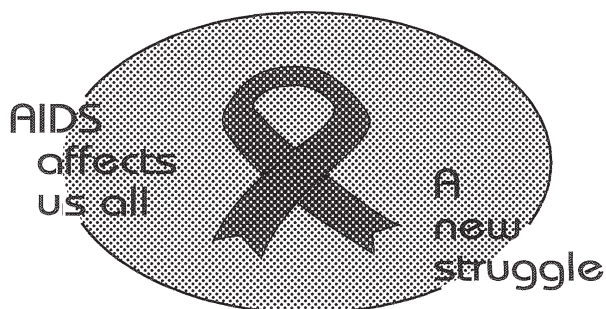

#### APPLICATION FOR CONSENT TO PROCURE 65% FINANCIAL INTEREST IN VENDIVISTA (PTY) LTD, LONIPLEX(PTY) LTD AND LONIVISTA(PTY) LTD BY HESHMO (PTY) LTD
