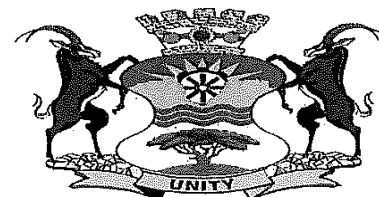

SUPPLEMENTARY VALUATION ROLL AND LODGING OF OBJECTIONS:**

Notice is hereby given in terms of section 49(1)(a) (read together with section 78(2) of the Local Government Municipal Property Rates Act, 2004 (Act No.6 of 2004), hereinafter referred to as the "ACT", that the Supplementary Valuation Roll for the financial years 1 July 2021 to 30 June 2022 is open for public inspection at the Rustenburg Local Municipality from 2nd June 2022 to 15 July 2022. In addition the Supplementary Valuation Roll is available on the Rustenburg Local Municipality website: www.rustenburg.gov.za and at the following venues and Regional Community Centers listed below on Mondays to Fridays during office hours from 07:30 to 16:00:

1. Municipal libraries situated at Boitekong; Karlienpark; Marikana and Rustenburg
2. Municipal Regional Community Centers (RCC) situated at Boitekong; Lethabong; Monnakato; Marikana; Phatsima and Tlhabane.

An invitation is hereby made in terms of section 49(1)(a) read together with section 78(2) of the Act that any owner of the property or other person who desires should lodge an objection with the Municipal Manager in respect of any matter including the category, reflected in, or omitted from, the Supplementary Valuation Roll within the abovementioned period.

Persons who cannot read and write may visit room 127 on the 1st Floor Missionary Mpheni House where an explanation will be given to such persons as well as provision of assistance regarding transcribing their comments or representation.

Attention is specifically drawn to the fact that in terms of section 50 (2) of the Act an objection must be in relation to a specific individual property and not against the Supplementary Valuation Roll. The forms for the lodging of objections are obtainable at the address below or website www.rustenburg.gov.za.


