

#### Re: REVIEW OF LISTS OF CANDIDATES BY PARTY

The above matter bears references.

The African National Congress as guided by the provisions of Item 21 of the Electoral Act 73 of 1998 (Schedule 1A), hereby review its undepleted lists as supplemented in terms of items 18, 19, and 20, within seven days after the expiry of the period referred to in item 19, and annually thereafter, until the date on which a party has to submit lists of candidates for an ensuing elections, in the following manner: a) all vacancies may be supplemented;

- b) no more than 25 per cent of candidates may be replaced; and
- c) the fixed order of lists may be changed.
