**FIRE BRIGADE SERVICES ACT, 1987
 (ACT NO 99 OF 1987):**

DECLARATION OF INSTITUTION AS A TRAINING INSTITUTION

Under section 7(1)(a) of the Fire Brigade Services Act, 1987 (Act No 99 of 1987), after consultation with the Training Board established by section 2 of the Local Government Training Act, 1985 (Act No 41 of 1985), and the Fire Brigade Board established by section 2 of the Fire Brigade Services Act, 1987, I hereby declare the Fire Brigade Service of the City of Cape Town to be a training institution for the presentation of the Preliminary Course in Fire Technology, on the conditions as set out in the accompanying Schedule.

Signed by me at Cape Town on this 30th day of January 1997.

SCHEDULE

- (a) The declaration shall apply for a period of one year, commencing on 1 November 1996 and ending on 31 October 1997.
- (b) The proficiency training prescribed in the Preliminary Course in Fire Technology shall only be examined by the training institution if a moderator who is in possession of a higher qualification in Fire Technology and is not associated with such fire brigade service where the training took place, is appointed to moderate the examination.
- (c) The training institution shall only present the proficiency component of the Preliminary Course in Fire Technology approved by the Fire Brigade Board and the Training Board.
- (d) The training institution shall have at its disposal the required facilities, equipment and appropriate manpower prescribed for the proficiency component of a module in the said Preliminary Course in Fire Technology, before such module may be presented.
