**AMENDMENT TO CLAUSE 27(2) OF  
PROCLAMATION 357 OF 1972**

Under section 79(e) of the Nature and Environmental Conservation Ordinance, 1974 (Ordinance 19 of 1974), I hereby amend, with effect from 1 June 1997, Proclamation No. 357 of 28 September 1972, as amended, by the substitution for clause 27(2) of the following clause:

“(2) catch or remove any bait or any kind of crab, burrowing aquatic fauna or octopus, unless he is the holder of a permit authorising him to do so”.


