WESTERN CAPE PROVINCIAL TREASURY**AMENDMENT OF ALLOCATIONS TO MUNICIPALITIES
NOT LISTED IN THE DIVISION OF REVENUE ACT,
2004 (ACT 5 OF 2004)**

I, Lynne Brown, in my capacity as Provincial Minister of Finance, Economic Development and Tourism hereby publish the attached schedule in terms of section 17(5) of the Division of Revenue Act, 2004, (Act No. 5 of 2004) which stipulates that, despite anything to the contrary contained in any law, a provincial treasury may, in accordance with any reporting framework determined by the National Treasury, make allocations to municipalities that were not, in terms of subsection 17(1) of this Act, included in Provincial Gazette Extraordinary No. 6119, dated 1 April 2004. Any changes in allocations contemplated must first be published in the relevant Provincial Gazette before any transfers can be made. Therefore, the original schedule is hereby amended.

Ek, Lynne Brown, in my hoedanigheid as Proviniale Minister van Finansies, Ekonomiese Ontwikkeling en Toerisme, publiseer hiermee die aangehegte skedule ingevolge artikel 17(5) van die Wet op die Verdeling van Inkomsste, 2004, (Wet Nr. 5 van 2004) wat bepaal dat, ondanks teenstrydige bepalings vervat in enige wetgewing, 'n provinsiale tesourie, in ooreenstemming met enige rapporteringsraamwerk soos deur die Nasionale Tesourie bepaal mag word, toekennings mag maak aan munisipaliteite wat, ingevolge subartikel 17(1) van die Wet, in die Buitengewone Proviniale Koerant No. 6119 gedateer 1 April 2004, nie ingesluit was nie. Enige wysigings in toekennings moet eers in die relevante Proviniale Koerant gepubliseer word, voordat enige oordragbetalings gedoen mag word. Gevolglik, word die oorspronklike skedule waarin die oordragbetaling as ongeallokeerd gepubliseer was, hiermee gewysig.

Name of allocation	DEVELOPMENT OF MULTI-PURPOSE CENTRES
Transferring provincial department	Department of Social Service and Poverty Alleviation
Purpose	To make government services and information accessible to poor and under resourced communities through the establishment of multi-purpose centres.
Measurable outputs	The establishment of multi-purpose centres in areas as outlined in the list.
Conditions	The area meets the criteria for identification of priority areas. Needs analysis completed. Architectural plans completed and approved. Tender specifications for buildings. Signed agreement between Province and municipality and between municipality and service provider. Further conditions as set out in the contract and approval letter.
Allocation criteria	Capacity building must be included as part of the scope of the project. Project must improve the accessibility of service delivery to the community. Project must improve the capacity of the Province to deliver services. Project must promote partnerships, integration and shared resources. Project must have long term impact on the community.
Reasons not incorporated in equitable share	In terms of section 154 (1) of the Constitution of the RSA, 1996 (Act 108 of 1996) the National Government and Provincial Governments, by legislative and other measures, must support and strengthen the capacity of municipalities to manage their own affairs, to exercise their powers and to perform their functions.
Monitoring mechanisms	Quarterly progress reports and monthly reports as required in clause 16 (1) of the Division of Revenue Act, 2004, (Act 5 of 2004). Visits to municipalities and attendance of steering committee meetings at municipalities by departmental personnel.
Projected life	The fund will be incorporated into a single grant in terms of the National Capacity Framework in 2005/06 for transfer directly to municipalities.
Payment schedule	Payment will be made as a single transfer.
