ACT

To authorise certain unauthorised expenditure in respect of the 2002/2003 financial year and to charge the Provincial Revenue Fund accordingly.

(Assented to 10 December 2004)*

BE IT ENACTED by the Provincial Parliament of the Province of the Western Cape, as follows:—

Authorisation of unauthorised expenditure for 2002/2003 financial year

1. (1) The Provincial Revenue Fund is charged with the amount of R28 020 833,77 to authorise certain unauthorised expenditure as set out in Schedule 1 hereunder for the 2002/2003 financial year, over and above the amounts appropriated for this service for the financial year which ended on 31 March 2003. 5

(2) The expenditure referred to in subsection (1) is described by reference to the Report of the Auditor-General and the explanatory memorandum as indicated in the footnote to the fifth and sixth column of the schedule to this Act. 10

(3) The expenditure is a direct charge against the Provincial Revenue Fund.

Short title

2. This Act is called the Western Cape First Finance Act, 2004.
