5. The requirements for appointment on the Commission are the following:
  - (a) Appointees must represent a broad cross-section of the youth of the Province and reflect a balance between youthfulness, experience and gender.
  - (b) Appointees must be fit for such appointment on account of any qualification, knowledge or experience relating to the functions of the Commission.
  - (c) Appointees may not be older than 35 years of age.
